

A RESOLUTION

1           WHEREAS, the President of the Federated States of Micronesia  
2 has nominated Mrs. Jane J. Chigiyal to serve as the FSM Ambassador  
3 Extraordinary and Plenipotentiary to the Commonwealth of  
4 Australia; and

5           WHEREAS, the nomination is subject to the advice and consent  
6 of Congress pursuant to Article X, section 2(d), of the  
7 Constitution of the Federated States of Micronesia and title 2 of  
8 the Code of the Federated States of Micronesia, section 207,  
9 (Annotated); and

10           WHEREAS, Mrs. Chigiyal held several important positions  
11 before within the Department of Foreign Affairs, including Deputy  
12 Secretary of the FSM Department of Foreign Affairs and Permanent  
13 Representative of the Federated States of Micronesia to the United  
14 Nations; and

15           WHEREAS, the nominee is equipped with qualifications and  
16 professional experience as a diplomat making her a suitable  
17 candidate to serve in this position; now, therefore,

18           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
19 States of Micronesia, Fifth Regular Session, 2024, that Congress  
20 hereby confirms the nomination of Mrs. Jane J. Chigiyal to serve


