10           WHEREAS, Mr. Joseph Giliko has the experience and  
11 qualifications which make him a suitable candidate to serve on

13 Trust Fund; and

14           WHEREAS, pursuant to section 1208 of title 55 of the Code  
15 of the Federated States of Micronesia (Annotated), as amended,  
16 Board members shall serve a term of four years; now, therefore,

17           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
18 States of Micronesia, Fifth Regular Session, 2024, that Congress  
19 hereby confirms the nomination of Mr. Joseph Giliko to serve as  
20 a member of the Board of Trustees of the Federated States of

1 Micronesia Trust Fund; and

2 BE IT FURTHER RESOLVED that certified copies of this  
3 resolution be transmitted to the President of the Federated  
4 States of Micronesia, the Governor of each state of the Nation  
5 and Mr. Joseph Giliko.


