A RESOLUTION

Authorizing the President to resubmit the nomination of Mr. Leonito M. Bacalando Jr., to serve as the Secretary of the Department of Justice of the Federated States of Micronesia.

1           WHEREAS, during the First Special Session of the Twenty-Third  
2 Congress the President submitted the nomination of Mr. Leonito M.  
3 Bacalando Jr. to serve as the Secretary of the Department of  
4 Justice of the Federated States of Micronesia; and

5           WHEREAS, the resolution approving the nomination has not been  
6 adopted by Congress; and

7           WHEREAS, under section 207 of title 2 of the Code of the  
8 Federated States of Micronesia (Annotated), as amended, any  
9 nomination previously rejected by Congress may not be resubmitted  
10 by the President during the Twenty-Third Congress without  
11 authorization from Congress; now therefore,

12           BE IT RESOLVED by the Twenty-Third Congress of the Federated  
13 States of Micronesia, Fifth Regular Session, 2024, that Congress  
14 hereby authorizes the President to resubmit the nomination of Mr.  
15 Leonito M. Bacalando Jr. to serve as the Secretary of the  
16 Department of Justice of the Federated States of Micronesia; and


