A RESOLUTION

To confirm the nomination of Mr. Alik K. Jackson to serve as the Kosrae State representative on the Federated States of Micronesia National Scholarship Board.

1 WHEREAS, section 392 of title 40 of the Code of the Federated
2 States of Micronesia (Annotated), provides that the FSM National
3 Scholarship Board ("the Board") shall consist of five (5) voting
4 members, including one from each state of the Federated States of
5 Micronesia, who shall be recommended by the Governor of the
6 relevant state. Each such recommended member of the Board shall
7 be nominated by the President with the advice and consent of the
8 Congress; and

9 WHEREAS, the President of the Federated States of Micronesia
10 has nominated Mr. Alik K. Jackson to serve on the Board as the
11 representative from the State of Kosrae; and

12 WHEREAS, Mr. Alik K. Jackson has the experience and
13 qualifications which make him a suitable candidate to serve on the
14 Board; now, therefore,

15 BE IT RESOLVED by the Twenty-Third Congress of the Federated
16 States of Micronesia, Third Special Session, 2024, that Congress
17 hereby confirms the nomination of Mr. Alik K. Jackson to serve as
18 a member on the Federated States of Micronesia National
19 Scholarship Board, representing the State of Kosrae; and

2 resolution be transmitted to the President of the Federated States
3 of Micronesia, the Secretary of Department of Education, and Mr.
4 Alik K. Jackson.




