A RESOLUTION

Approving and accepting a grant in the amount of \$114,354 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to fund and support the Preventive Health and Health Services Block Grant Community Project, including all the terms and conditions of the assistance.

1 WHEREAS, on August 26, 2024, the United States Department of
2 Health and Human Services, Centers for Disease Control and
3 Prevention, issued a Notice of Award of a grant in the amount of
4 \$114,354, to fund and support the 2024 FSM Preventive Health and
5 Health Services Block Grant Community Project; and

6 WHEREAS, the budget period for this grant is from October 1,
7 2023, to September 30, 2025; and

8 WHEREAS, the purpose of the grant is to fund and support the
9 implementation of the project and its related activities in
10 addressing various health issues such as accessing safe and clean
11 water in underserved communities, combating non-communicable
12 diseases through sports and youth engagement, and the prevention
13 of sexual offenses; and

14 WHEREAS, section 210(2) of title 55 of the Code of the
15 Federated States of Micronesia (Annotated), as amended, provides
16 that for foreign financial assistance to be valid it must be
17 approved by Congress by resolution; now, therefore,

18 BE IT RESOLVED by the Twenty-Third Congress of the Federated
19 States of Micronesia, Fifth Regular Session, 2024, that Congress

1 hereby approves and accepts the \$114,354 grant from the United
2 States Department of Health and Human Services, Centers for
3 Disease Control and Prevention, to fund and support the 2024 FSM
4 Preventive Health and Health Services Block Grant Community
5 Project, including all the terms and conditions thereof; and

6 BE IT FURTHER RESOLVED that certified copies of this
7 resolution be transmitted to the President of the Federated
8 States of Micronesia, the Secretary of the Department of Health
9 and Social Affairs, the Secretary of the Department of Finance
10 and Administration, and the Secretary of the Department of
11 Justice.


