

A RESOLUTION

Setting forth the sum of the total funds estimated to be available for appropriation from the General Fund of the Federated States of Micronesia and the United States Grant Special Fund for fiscal year 1985.

1 WHEREAS, section 104 of title 55 of the Code of the Federated
2 States of Micronesia requires that Congress adopt a resolution setting
3 forth the total funds estimated to be available for appropriation from
4 the General Fund of the Federated States of Micronesia and any special
5 funds of the National Treasury for each fiscal year; and

6 WHEREAS, the total appropriations for fiscal year 1985 may not
7 exceed the total funds estimated to be available for appropriation in
8 the General Fund of the Federated States of Micronesia and the United
9 States Grant Special Fund for fiscal year 1985 as expressed in the
10 aforementioned resolution; and

11 WHEREAS, the total funds estimated to be available for appropria-
12 tion in the General Fund of the Federated States of Micronesia for fiscal
13 year 1985 are \$9,700,000; and


14 WHEREAS, the total funds estimated to be available for appropria-
15 tion in the United States Grant Special Fund for fiscal year 1985 are
16 \$6,972,825; now, therefore,

17 BE IT RESOLVED by the Fourth Congress of the Federated States of
18 Micronesia, First Regular Session, 1985, that appropriations for fiscal
19 year 1985 from the General Fund of the Federated States of Micronesia
20 shall not exceed \$9,700,000 and that appropriations for fiscal year 1985
21 from the United States Grant Special Fund shall not exceed \$6,972,825;


