

AN ACT

To further amend Public Law No. 22-180, as amended by Public Laws Nos. 22-187, 22-188, 23-03, 23-09, 23-11, 23-36, 23-59 and 23-118, by amending section 6 thereof, for the purpose of changing the allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2 Section 1. Section 6 of Public Law No. 22-180, as
3 amended by Public Laws Nos. 22-188, 23-11, 23-36 and 23-118, is
4 hereby further amended to read as follows:

5 "Section 6. Allotment and management of funds and lapse
6 date. All funds appropriated by this act shall be
7 allotted, managed, administered and accounted for in
8 accordance with applicable laws, including, but not
9 limited to, the Financial Management Act of 1979. The
10 allottee shall be responsible for ensuring that these
11 funds, or so much thereof as may be necessary, are used
12 solely for the purpose specified in this act, and that
13 no obligations are incurred in excess of the sum
14 appropriated. The allottee of the funds appropriated
15 under section 2 of this act shall be the Governor of Yap
16 State or his designee. The allottee of funds
17 appropriated under sections 3 and 4 of this act shall be
18 the President of the Federated States of Micronesia or

1 his designee; EXCEPT THAT, the allottee of funds
2 appropriated under section 3(1) of this act shall be the
3 Governor of Kosrae State or his designee; the allottee
4 of funds appropriated under section 3(2) of this act
5 shall be the Mayor of Lelu Town Government or his
6 designee; PROVIDED THAT, the allottee of funds
7 appropriated under subsection 3(2)(x) of this act shall
8 be the Mayor of Utwe Municipal Government or his
9 designee; the allottee of funds appropriated under
10 subsection 3(2)(y) of this act shall be the Mayor of
11 Malem or his designee; the allottee of funds
12 appropriated under subsections 4(1)(b), 4(1)(k),
13 4(1)(l), 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d), 4(2)(e),
14 4(2)(g), 4(2)(h), 4(2)(p), 4(2)(s), 4(2)(t), 4(2)(u),
15 4(2)(v), 4(3)(q) and 4(2)(aa) and 4(2)(ab) of this act
16 shall be the Secretary of the Department of
17 Transportation, Communications and Infrastructure or his
18 designee; the allottee of funds appropriated under
19 subsections 4(1)(a), 4(1)(j), 4(2)(f), 4(2)(j), 4(2)(k),
20 4(2)(l), 4(2)(m), 4(2)(r), 4(2)(x), 4(3)(m) and 4(2)(n)
21 of this act shall be the Pohnpei Transportation
22 Authority (PTA); the allottee of funds appropriated
23 under subsection 4(2)(i) of this act shall be the
24 Secretary of the Department of Education or her
25 designee; the allottee of funds appropriated under

1 subsection 4(2)(o) of this act shall be the Pohnpei Port
2 Authority (PPA); the allottee of funds appropriated
3 under subsections 4(2)(w), 4(2)(q) and 4(2)(z) of this
4 act shall be the Mayor of Sapwuahfik Municipal
5 Government or his designee, the allottee of funds
6 appropriated under subsections 4(2)(ac) and 4(2)(ad) of
7 this act shall be the Sokehs Municipal Government; the
8 allottee of the funds appropriated under subsections
9 5(1) and 5(6) of this act shall be the Governor of Chuuk
10 State or his designee; the allottee of the funds
11 appropriated under subsection 5(2) of this act shall be
12 the Mortlocks Island Development Authority (MIDA); the
13 allottee of the funds appropriated under subsection 5(3)
14 of this act shall be the Mayor of Weno Municipal
15 Government or his designee; the allottee of the funds
16 appropriated under subsection 5(4) of this act shall be
17 the Southern Namoneas Development Authority; the
18 allottee of the funds appropriated under subsection 5(5)
19 of this act shall be the Faichuk Development Authority.
20 The authority of the allottee to obligate funds
21 appropriated by this act shall lapse on September 30,
22 2025.”

3 becoming law without such approval.
