A RESOLUTION

Distributing the goods and services to be made available under the recently concluded agreement between the Micronesian Maritime Authority and the Federation of Japan Tuna Fisheries Co-operative Associations, the National Offshore Tuna Fisheries Association of Japan, the Japan Far Seas Purse Seine Fishing Association, and the Federation of North Pacific District Purse Seine Fisheries Co-operative Associations of Japan.

1 WHEREAS, the Micronesian Maritime Authority did conclude an  
2 agreement entitled:

3 "AGREEMENT BETWEEN THE MICRONESIAN MARITIME AUTHORITY OF  
4 THE FEDERATED STATES OF MICRONESIA AND FEDERATION OF JAPAN  
5 TUNA FISHERIES CO-OPERATIVE ASSOCIATIONS, NATIONAL OFFSHORE  
6 TUNA FISHERIES ASSOCIATION OF JAPAN, JAPAN FAR SEAS PURSE  
7 SEINE FISHING ASSOCIATION AND FEDERATION OF NORTH PACIFIC  
8 DISTRICT PURSE SEINE FISHERIES CO-OPERATIVE ASSOCIATIONS  
9 OF JAPAN, CONCERNING THE SUPPLY OF GOODS AND SERVICES FOR  
10 THE DEVELOPMENT OF THE FISHERIES OF THE FEDERATED STATES  
11 OF MICRONESIA"; and

12 WHEREAS, the Congress of the Federated States of Micronesia did,  
13 on August 9, 1984, ratify this agreement, by adoption of Congressional  
14 Resolution No. 3-156, C.D.1; and

15 WHEREAS, under the terms of this agreement, goods and services  
16 with the value of approximately ¥60 million will be provided to the  
17 Federated States of Micronesia; and

18 WHEREAS, section 415(3) of title 24 of the Code of the Federated  
19 States of Micronesia provides that fees from foreign fishing agreements  
20 paid in goods and services shall be distributed by resolution of the  
21 Congress of the Federated States of Micronesia; and

22 WHEREAS, it is the sense of the Congress of the Federated States  
23 of Micronesia that the decision of the chief executives of the  
24 Federated States of Micronesia at their meetings in June and July of  
25 1982 regarding goods and services from fishing agreements should be

1 honored; and

2 WHEREAS, the Congress of the Federated States of Micronesia  
3 concurred in the decision of the chief executives to distribute  
4 goods and services from fishing agreements for this year to the States  
5 of Kosrae and Yap; now, therefore,

6 BE IT RESOLVED by the Third Congress of the Federated States of  
7 Micronesia, Third Special Session, 1984, that the goods and services  
8 provided under the agreement referenced above be hereby distributed  
9 in monetary value as follows:

10 Kosrae . . . . . ¥26,385,948

11 Yap . . . . . ¥33,614,052; and

12 BE IT FURTHER RESOLVED that certified copies of this resolution  
13 be transmitted to the President of the Federated States of Micronesia,  
14 the Governor of Truk State, the Speaker of the Truk State Legislature,  
15 the Governor of Ponape State, the Speaker of the Ponape State Legisla-  
16 ture, the Governor of Yap State, the Speaker of the Yap State Legisla-  
17 ture, the Governor of Kosrae State, the Speaker of the Kosrae State  
18 Legislature, and the Executive Director of the Micronesian Maritime  
19 Authority.
