A RESOLUTION

Respectfully requesting the Congress of the United States of America to fully fund the fiscal year 1984 operations budget for the State and National Governments of the Federated States of Micronesia and to enact the \$4.07 million supplemental request to that budget.

1           WHEREAS, the United States Department of the Interior has requested  
2 \$36.9 million for the operations of the State and National Governments  
3 of the Federated States of Micronesia for fiscal year 1984; and

4           WHEREAS, the National Government of the Federated States of  
5 Micronesia has delivered to the Congress of the United States of  
6 America a supplemental operations budget request for \$4.07 million;  
7 and

8           WHEREAS, the supplemental budget request is composed of \$1.6  
9 million to fund public works operations, which was subtracted from the  
10 fiscal year 1983 operations budget and used for cholera control; \$1.5  
11 million to fund specialized health personnel and health education and  
12 medical referral programs; and \$970,000 to purchase used heavy equip-  
13 ment from demobilizing OICC/CIP contractors; and

14           WHEREAS, the funding of the supplemental budget request combined  
15 with full funding of the original operations budget request will  
16 strengthen the efforts of the Federated States of Micronesia to provide  
17 both improved basic social services and a solid base for capital  
18 infrastructure so vital for economic development; now, therefore,

19           BE IT RESOLVED by the Third Congress of the Federated States of  
20 Micronesia, First Regular Session, 1983, that the Congress of the  
21 Federated States of Micronesia respectfully requests the Congress of  
22 the United States of America to fully fund the fiscal year 1984  
23 operations budget for the State and National Governments of the  
24 Federated States of Micronesia and to enact the \$4.07 million supple-  
25 mental request to that budget; and
