
I am transmitting the following Congressional Act, which I have signed into Public Law No. 23-146:

AN ACT

To amend Public Law No. 23-122, as amended by Public Law No. 23-138, by amending section 2 thereof, to change the use of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 2 of Public Law No. 23-122 is hereby  
2 amended to read as follows:

3 Section 2. Of the \$1,680,000, appropriated under this act,  
4 \$240,000 shall be apportioned to fund public projects and social  
5 programs for the people of Yap.
