CERTIFICATION OF THE SPECIAL ELECTION RESULTS OF NOVEMBER 12, 2021

Whereas, the FSM Special Election in Election District No. 3, the Southern Namoneas Region, in the State of Chuuk was held on November 12, 2021, and;

Whereas, the Counting and Tabulating Committee in the FSM State of Chuuk has thoroughly counted and tallied all ballots cast during the Special Election inclusive of all kinds of absentee ballots, and;

Whereas, the FSM Acting National Election Commissioner for the State of Chuuk has now fully completed and certified the outcome of the Special Election in Chuuk as the Official Results;

Be It Resolved, that the delay in the declaration of the official result winner was made as a result of a Decree issued by the President on October 12, 2021, postponing the cut-off date of receipt of mail-in absentee ballots to November 26, 2021;

Be It Further Resolved, that the certification of the Special Election Official Results be transmitted to the President and the Vice President of the Federated States of Micronesia, the Speaker and Members of the Twenty-Second FSM Congress, the Members of the Cabinet, the Governor of the State of Chuuk, the Mayors of the Southern Namoneas Region and the Candidates;

Now Therefore, pursuant to the authority vested upon me as the National Election Director under Section 303 (8) of Title 9 of the FSM Code, I hereby officially declare and certify the winning candidate, receiving the plurality votes cast in the two-year term in Election District No. 3, in Chuuk Special Election of November 12, 2021.
