Your Committee on Ways and Means, to which was referred Presidential Communication No. 23-146, regarding the veto of Congressional Act No. 23-19, entitled:

"AN ACT TO FURTHER AMEND SECTIONS 303 AND 306 OF TITLE 55 OF THE CODE OF THE FEDERATED STATES OF MICRONESIA (ANNOTATED), AS AMENDED BY PUBLIC LAWS NOS. 18-12, 18-25 AND 18-57, TO MODIFY THE DISTRIBUTION FORMULA FOR COMPACT FUNDS TO ALLOW THE NATIONAL GOVERNMENT A 10% SHARE OF THE DISTRIBUTION, TO INSERT A NEW SECTION 306A OF TITLE 55 OF THE CODE OF THE FEDERATED STATES OF MICRONESIA (ANNOTATED), CONTAINING TRANSITIONAL PROVISIONS FOR FISCAL YEAR 2024, TO CENTRALIZE THE COMPACT INFRASTRUCTURE SECTOR GRANTS WITHIN THE DEPARTMENT OF TRANSPORTATION, COMMUNICATIONS AND INFRASTRUCTURE, AND FOR OTHER PURPOSES.",
