To further amend Public Law No. 20-125, as amended by Public Laws Nos. 20-135, 20-146, 20-157, 20-179, 20-189, 21-06, 21-40, 21-59, 21-89, 21-96, 21-141, 21-155, 21-217, 21-225, 21-230, 21-239, 22-20, 22-70, 22-88, 22-95, 22-144, 22-201, 23-51, 23-70, 23-102 and 23-132 by amending section 3 thereof, to change the use of certain funds previously appropriated therein, to fund public projects and social programs for the people of the state of Kosrae, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:
