
A RESOLUTION

CONGRESSIONAL RESOLUTION NO. 24-24

A RESOLUTION

Approving and accepting a grant in the amount of ¥300,000,000 from the Government of Japan, to contribute to the implementation of the Economic and Social Development Program of the FSM, including all the terms and conditions of the assistance.

1 WHEREAS, following mutual consultations, the Government of
2 Japan agreed to provide ¥300,000,000 to the Government of the
3 Federated States of Micronesia, for the purpose of contributing to
4 the implementation of the Economic and Social Development Program
5 of the FSM; and

6 WHEREAS, the grant is evidenced by the Exchange of Notes,
7 Record of Discussions and Agreed Minutes on Procedural Details
8 dated February 2, 2023, between the FSM Department of Foreign
9 Affairs and the Japanese Embassy in Kolonia; and

10 WHEREAS, that the Government of the Federated States of
11 Micronesia wishes to express its appreciation and gratitude to
12 the Government of Japan for extending this grant; and

13 WHEREAS, section 210(2) of title 55 of the Code of the
14 Federated States of Micronesia (Annotated), as amended; requires
15 that the foreign financial assistance to be valid, it must be
16 approved by Congress by resolution; now, therefore,

17 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
18 States of Micronesia, First Regular Session, 2025, that Congress
19 hereby approves and accepts the ¥300,000,000 grant from the

1 Government of Japan, including all the terms and conditions
2 thereof; and

3 BE IT FURTHER RESOLVED that the certified copies of this
4 resolution be transmitted to the President of the Federated
5 States of Micronesia, the Secretary of the Department of Justice,
6 and the Secretary of the Department of Foreign Affairs.


