To approve and accept a grant in the amount of \$7,500,000 from the World Bank, for providing support to the Implementation Capacity for Transformative Results Project (IMPACT), including all the terms and conditions of the assistance.

1       WHEREAS, the World Bank issued a Grant Award on April 25,  
2   2025, to the Government of the Federated States of Micronesia  
3   providing funding in the amount of \$7,500,000 for the purpose of  
4   providing support to the Implementation Capacity for  
5   Transformative Results Project (IMPACT); and

6       WHEREAS, section 210(2) of title 55 of the Code of the  
7   Federated States of Micronesia (Annotated), as amended, provides  
8   that for foreign financial assistance to be valid it must be  
9   approved by Congress by resolution, and

10       WHEREAS, the Government of the Federated States of Micronesia  
11   wishes to express its appreciation and gratitude to the World  
12   Bank for extending this grant; now, therefore,

13       BE IT RESOLVED by the Twenty-Fourth Congress of the Federated  
14   States of Micronesia, First Special Session, 2025, that Congress  
15   hereby approves and accepts the \$7,500,000 grant from the World  
16   Bank, including all the terms and conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this
