A RESOLUTION

To approve and accept a grant in the amount \$194,908 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment, to fund the Substance Abuse Prevention, Treatment, and Recovery Services Block Grant in the Federated States of Micronesia, including all the terms and conditions of the assistance.

1       WHEREAS, the Substance Abuse Prevention, Treatment, and  
2 Recovery Services Block Grant, administered by the United States  
3 Department of Health and Human Services through the Substance  
4 Abuse and Mental Health Services Administration Center for  
5 Substance Abuse Treatment, issued a Grant Award on June 09,  
6 2025, to the Government of the Federated States of Micronesia in  
7 the amount of \$194,908; and

8       WHEREAS, the purpose of this grant is to provide financial  
9 support to the FSM Department of Health & Social Affairs for the  
10 planning, implementation, and evaluation of evidence-based  
11 activities that (i) prevent substance use, (ii) treat substance  
12 use disorders, and (iii) support long-term recovery services  
13 among youth and other targeted populations throughout the FSM;  
14 and;

15       WHEREAS, section 210(2) of title 55 of the Code of the  
16 Federated States of Micronesia (Annotated), as amended, requires

1 that for foreign financial assistance to be valid it must be  
2 approved by Congress by resolution; now, therefore,

3 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated  
4 States of Micronesia, First Special Session, 2025, that Congress  
5 hereby approves and accepts the grant in the amount of \$194,908  
6 from the United States Department of Health and Human Services,  
7 Substance Abuse and Mental Health Services Administration, Center  
8 for Substance Abuse Treatment, including all the terms and  
9 conditions thereof; and

10 BE IT FURTHER RESOLVED that certified copies of this  
11 resolution be transmitted to the President of the Federated  
12 States of Micronesia, the Secretary of the Department of Health  
13 and Social Affairs, and the Secretary of the Department of  
14 Justice.
