

CONGRESSIONAL RESOLUTION NO. 24-32

A RESOLUTION

Approving and accepting a grant in the amount of \$1,588,832 from the United States Department of Education, to fund the Special Education Program in the Federated States of Micronesia, including all the terms and conditions of the assistance.

1 WHEREAS, on June 30, 2025, the United States Department of
2 Education issued a Grant Award in the amount of \$1,588,832 for the
3 budget period from July 1, 2025, to September 30, 2026; and

4 WHEREAS, the purpose of the grant is to fund and support the
5 implementation of the FSM Special Education Program and its
6 related services for eligible children with disabilities
7 throughout the FSM; and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended, provides
10 that for foreign financial assistance to be valid it must be
11 approved by Congress by resolution; now, therefore,


12 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
13 States of Micronesia, First Special Session, 2025, that Congress
14 hereby approves and accepts the \$1,588,832 grant from the United
15 States Department Education, to fund the Special Education Program
16 in the Federated States of Micronesia, including all the terms and
17 conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this
