A RESOLUTION

Approving and accepting a grant in the amount of \$128,780 from the United States Department of Health and Human Services, Health Resources and Services Administration, to fund the Universal Newborn Early Hearing Screening and Intervention Program in the Federated States of Micronesia, including all the terms and conditions of the assistance.

1 WHEREAS, on June 27, 2025, the United States Department of
2 Health and Human Services, Health Resources and Services
3 Administration, issued a Grant Award in the amount of \$128,780 to
4 fund the Universal Newborn Early Hearing Screening and
5 Intervention Program; and

6 WHEREAS, the purpose of the grant is to fund the
7 implementation of the Universal Newborn Early Hearing Screening
8 Program within the Federated States of Micronesia; and

9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, provides
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; now, therefore,

13 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
14 States of Micronesia, First Special Session, 2025, that Congress
15 hereby approves and accepts the \$128,780 grant from the United
16 States Department of Health and Human Services, Health Resources
17 and Services Administration, to fund the Universal Newborn Early
18 Hearing Screening Intervention Program in the Federated States of

1 Micronesia, including all the terms and conditions thereof; and

2 BE IT FURTHER RESOLVED that certified copies of this
3 resolution be transmitted to the President of the Federated
4 States of Micronesia, the Secretary of the of Health and Social
5 Affairs, and the Secretary of the Department of Finance and
6 Administration.


