A RESOLUTION

To approve and accept a grant in the amount of \$272,498 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention (CDC), to fund the FSM Department of Health and Social Affairs' Communicable Disease Program, including all terms and conditions of the assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services, Centers for Disease Control and Prevention (CDC), issued
3 a Grant Award on July 08, 2025, to the Government of the Federated
4 States of Micronesia in the amount of \$272,498; and

5 WHEREAS, the purpose this funding is to strengthen and
6 accelerate the FSM Department of Health and Social Affairs'
7 Communicable Disease Program, particularly in the areas of
8 prevention and control of HIV, Viral Hepatitis, Sexually
9 Transmitted Infections (STIs), and Tuberculosis (TB); and

10 WHEREAS, this supplemental grant will support efforts to
11 enhance surveillance, improve case detection and contact tracing,
12 expand outreach and public health education, and ensure better
13 access to treatment and care across the FSM; and

14 WHEREAS, section 210(2) of title 55 of the Code of the
15 Federated States of Micronesia (Annotated), as amended, requires
16 that for foreign financial assistance to be valid it must be
17 approved by Congress by resolution; now, therefore,

18 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
19 States of Micronesia, First Special Session, 2025, that Congress

1 grant from the United States Department of Health and Human
2 Services, Centers for Disease Control and Prevention, including
3 all terms and conditions thereof; and

4 BE IT FURTHER RESOLVED that certified copies of this
5 resolution be transmitted to the President of the Federated
6 States of Micronesia, the Secretary of the Department of Health
7 and Social Affairs, and the Secretary of the Department of
8 Justice.


