A RESOLUTION

To approve and accept a grant in the amount of the \$1,258,223 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to fund and support the FSM Comprehensive Cancer Control Program, including terms and conditions of the assistance.

1 WHEREAS, the United States Department of Health and Human
2 Services, Centers for Disease Central and Prevention, issued a
3 Grant Award on July 01, 2025, to the Government of the Federated
4 States of Micronesia providing funding in the amount of \$1,258,223
5 for the purpose of providing support to the FSM Comprehensive
6 Cancer Control Program; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, requires
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; and

11 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
12 States of Micronesia, First Special Session, 2025, that Congress
13 hereby approves and accepts the \$1,258,223 grant from the United
14 States Department of Health and Human Services, Centers for
15 Disease Central and Prevention, including all the terms and
16 conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this
