A RESOLUTION

Setting the ceiling of the total funds estimated to be available for appropriation from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2025.

1 WHEREAS, section 104 of title 55 of the Code of the Federated
2 States of Micronesia (Annotated), as amended, requires that
3 Congress adopt a resolution setting forth the total funds
4 estimated to be available for appropriation from the General Fund
5 and any special funds of the National Treasury of the Federated
6 States of Micronesia for each fiscal year; now, therefore,

7 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
8 States of Micronesia, First Special Session, 2025, that the amount
9 estimated to be available for appropriation for the fiscal year
10 ending September 30, 2025, is set at \$151,992,177 of which
11 \$84,745,465 is from domestic revenues, \$12,226,712 is from the
12 Compact Operation Sector Grants, \$35,000,000 (inclusive of the
13 sub-grants to the States) is from the Compact Infrastructure
14 Sector Grant, and \$20,020,000 (inclusive of the sub-grants to the
15 States) is from the Compact IMF Grant; and




