Approving and accepting a grant in the amount of \$1,236,841 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to fund the Immunization Program in the Federated States of Micronesia, including all the terms and conditions of the assistance.

1 WHEREAS, on June 26, 2025, the United States Department of
2 Health and Human Services, Centers for Disease Control and
3 Prevention, issued a Grant Award in the amount of \$1,236,841 to
4 fund the Immunization Program in the FSM; and

5 WHEREAS, the purpose of the assistance is to strengthen
6 immunization and vaccines for children in Federated States of
7 Micronesia; and

8 WHEREAS, section 210(2) of title 55 of the Code of the
9 Federated States of Micronesia (Annotated), as amended, provides
10 that for foreign financial assistance to be valid it must be
11 approved by Congress by resolution; now, therefore,


12 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
13 States of Micronesia, First Special Session, 2025, that Congress
14 hereby approves and accepts the \$1,236,841 grant from the United
15 States Department of Health and Human Services, Centers for
16 Disease Control and Prevention, to fund the FSM Immunization
17 Program, including all the terms and conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this
