A RESOLUTION

Approving and accepting a grant in the amount of \$118,662 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Centers for Mental Health Services, to fund and support Community Mental Health Services in the Federated States of Micronesia, including all the terms and conditions of the assistance.

1       WHEREAS, on July 30, 2025, the United States Department of  
2   Health and Human Services, Substance Abuse and Mental Health  
3   Services Administration, Centers for Mental Health Services,  
4   issued a Grant Award in the amount \$118,662 to the Government of  
5   the Federated States of Micronesia;

6       WHEREAS, the purpose of this grant is to fund and support the  
7   Community Mental Health Services initiatives in the Federated  
8   States of Micronesia; and

9       WHEREAS, the budget period for this grant is from October 1,  
10   2024 to September 30, 2026; and

11       WHEREAS, section 210(2) of title 55 of the Code of the  
12   Federated States of Micronesia (Annotated), as amended, provides  
13   that for foreign financial assistance to be valid it must be  
14   approved by Congress by resolution; now, therefore,

15       BE IT RESOLVED by the Twenty-Fourth Congress of the Federated  
16   States of Micronesia, First Special Session, 2025, that Congress  
17   hereby approves and accepts the \$118,662 grant from the United  
18   States Department of Health and Human Services, Substance Abuse

1 and Mental Health Services Administration, Centers for Mental  
2 Health Services, including all the terms and conditions thereof;

4 BE IT FURTHER RESOLVED that certified copies of this  
5 resolution be transmitted to the President of the Federated States  
6 of Micronesia, the Secretary of the Department of Health and  
7 Social Affairs, the Secretary of the Department of Justice, and  
8 the Secretary of the Department of Finance and Administration.


