A RESOLUTION

Approving and accepting a grant in the amount of SDR 13,600,000 (Special Drawing Rights) from the World Bank, for the purpose of funding a project in the Federated States of Micronesia entitled: "Digital Federated States of Micronesia Project", including all the terms and conditions of the assistance.

1           WHEREAS, the Government of the Federated States of  
2 Micronesia, represented by the Secretary of the Department of  
3 Finance and Administration, and the International Development  
4 Association (World Bank) entered into a Financing Agreement in  
5 July 17, 2025, providing a grant to the Federates of Micronesia On  
6 the amount of SDR 13,600,000 (Special Drawing Rights) to provide  
7 supplemental funding for the Digital FSM Project; and

8           WHEREAS, section 210(2) of title 55 of the Code of the  
9 Federated Stats of Micronesia (Annotated), as amended, provides  
10 that for foreign financial assistance to be valid it must be  
11 approved by Congress by resolution; and

12           WHEREAS, the Government of the Federated States of Micronesia  
13 wishes to express its appreciation and gratitude to the World  
14 Bank for this generous grant extended to the FSM Government; now,  
15 therefore,

16           BE IT RESOLVED by the Congress of the Federated States of  
17 Micronesia, First Special Session, 2025, that Congress hereby  
18 approve and accepts the SDR 13,000,000 grant from the World Bank  
19 to provide funding for the Digital FSM Project, including all the

1 terms and conditions thereof; and

2 BE IT FURTHER RESOLVED that certified copies of this  
3 resolution be transmitted to the President of the Federated  
4 States of Micronesia, the Secretary of the Department of Justice,  
5 the Secretary of the Department of Foreign Affairs, and the  
6 Secretary of the Department of Finance and Administration.


