
A RESOLUTION

A RESOLUTION

To approve and accept a grant in the amount of \$417,492 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to support the FSM Noncommunicable Disease (NDC) Program, including all the terms and conditions of the assistance.

1 WHREAS, the United States Department of Health and Human
2 Services, Centers for Disease Central and Prevention, issued a
3 Grant Award on June 26, 2025, to the Government of the Federated
4 States of Micronesia to providing funding in the amount of
5 \$417,492 for the purpose of providing support to the FSM
6 Noncommunicable Disease (NCD) Program; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, requires
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; now, therefore,

11 BE IT RESOLVED by the Twenty-Fourth Congress of the
12 Federated States of Micronesia, First Special Session, 2025,
13 that Congress hereby approves and accepts the \$417,492 grant
14 from the United States Department of Health and Human Services,
15 including all the terms and conditions thereof; and


