

A BILL FOR AN ACT

To further amend Public Law No. 18-99, as amended by Public Laws Nos. 18-106, 18-113, 18-121, 19-05, 19-34, 19-57, 19-74, 19-107, 20-18, 20-24, 20-80, 20-112, 21-28, 21-106, 21-131, 21-177, 22-129 and 23-81, by amending sections 4 and 6 thereof, to extend the lapse date and use of funds previously appropriated therein, to fund public projects and social programs for the people of the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 4 of Public Law No. 18-99, as amended by  
2 Public Law No. 18-113, 18-121, 19-05, 19-34 and 20-18, is hereby  
3 amended to read as follows:  
4           "Section 4. Of the \$2,800,000 appropriated in this act,  
5           \$800,000 is appropriated for public projects and social  
6           programs for the people of the State of Pohnpei.

17 Section 2. Section 6 of Public Law No. 18-99, as amended  
18 by Public Laws Nos. 18-113, 18-121, 19-05, 19-34, 19-107, 20-18,  
19 20-24, 20-112, 21-28, 21-131, 22-129 and 23-91, is hereby  
20 further amended to read as follows:

21 "Section 6. Allotment and management of funds and lapse  
22 date. All funds appropriated by this act shall be  
23 allotted, managed, administered and accounted for in  
24 accordance with applicable laws, including, but not  
25 limited to, the Financial Management Act of 1979. The

1 allottee shall be responsible for ensuring that these  
2 funds, or so much thereof as may be necessary, are used  
3 solely for the purpose specified in this act, and that  
4 no obligations are incurred in excess of the sum  
5 appropriated. The allottee of the funds appropriated  
6 under section 2 of this act shall be the Governor of Yap  
7 State or his designee. The allottee of funds  
8 appropriated under section 3 shall be the President or  
9 his designee, EXCEPT THAT the allottee of funds  
10 appropriated under section 3(a), (b), (c), (d), (e),  
11 (f), (g), (h), (i), (j), (k), (l), (m), (n), (o), (u)  
12 and (y) shall be the Mayor of Lelu Town Government. The  
13 allottee of funds appropriated under section 4 of this  
14 act shall be the President or his designee, EXCEPT that  
15 the allottee of funds appropriated under section 4(1)(a)  
16 shall be the Secretary of the Department of Education;  
17 the allottee of funds appropriated under sections  
18 4(1)(c), 4(1)(e), 4(1)(h), 4(2) and [~~4(3)(a)~~] 4(3)(b) to  
19 4(3)(j) shall be Secretary of the Department of  
20 Transportation, Communications and Infrastructure or his  
21 designee; the allottee of funds appropriated under  
22 section 4(1)(d) shall be the Pohnpei Port Authority; the  
23 allottee of funds appropriated under section 4(1)(f)  
24 shall be the Nett District Government; the allottee of  
25 funds appropriated under section 4(1)(g) shall be the

1 Secretary of the Department of Resources and  
2 Development. The allottee of funds appropriated under  
3 section 4(1)(a) shall be the Pohnpei Transportation  
4 Authority. The allottee of funds appropriated under  
5 section 4(1)(k) shall be the Secretary of the Department  
6 of Health and Social Affairs or his designee. The  
7 allottee of funds appropriated under sections 5(1) and  
8 5(6) of this act shall be the Governor of Chuuk State or  
9 his designee. The allottee of funds appropriated under  
10 subsection 5(2) of this act shall be the Mortlock  
11 Islands Development Authority. The allottee of funds  
12 appropriated under subsection 5(3) of this act shall be  
13 the Mayor of Weno Municipal Government or his designee.  
14 The allottee of funds appropriated under subsection 5(4)  
15 of this act shall be the Southern Namoneas Development  
16 Authority. The allottee of funds appropriated under  
17 subsection 5(5) of this act shall be the Faichuk  
18 Development Authority. The authority of the allottee to  
19 obligate funds appropriated by this act shall lapse on  
20 September 30, 2026.”

1       Section 3. This act shall become law upon approval by the  
2 President of the Federated States of Micronesia or upon its  
3 becoming law without such approval.
