

A BILL FOR AN ACT

To further amend Public Law No. 22-186, as amended by Public Laws Nos. 22-189, 23-01, 23-14, 23-47, 23-73, 23-107, 23-126 and 23-169, by amending sections 4 and 6 thereof, to change the use, allottee and lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 22-186, as amended by
2 Public Laws Nos. 22-189, 23-01, 23-47, 23-73, 23-107, 23-126 and
3 23-169, is hereby further amended to read as follows:
4 "Section 4. Of the \$5,600,000 appropriated under this
5 act, \$1,600,000 shall be apportioned for public projects
6 and social programs for the people of Pohnpei State.

18 Section 2. Section 6 of Public Law No. 22-186, as amended by
19 Public Laws Nos. 22-189, 23-47 and 23-72, is hereby further
20 amended to read as follows:

21 "Section 6. Allotment and management of funds and lapse
22 date. All funds appropriated by this act shall be
23 allotted, managed, administered and accounted for in
24 accordance with applicable laws, including, but not
25 limited to, the Financial Management Act of 1979. The

1 allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are used
3 solely for the purpose specified in this act, and that
4 no obligations are incurred in excess of the sum
5 appropriated. The allottee of the funds appropriated
6 under section 2 of this act shall be the Governor of Yap
7 State or his designee; EXCEPT THAT the allottee of funds
8 appropriated under section 2(i) of this act shall be the
9 President of the Federated States of Micronesia or his
10 designee. The allottee of funds appropriated under
11 sections 3 and 4 of this act shall be the President of
12 the Federated States of Micronesia or his designee;
13 EXCEPT THAT, the allottee of funds appropriated under
14 section 3(1) of this act shall be the Governor of Kosrae
15 State or his designee; the allottee of funds
16 appropriated under section 3(2) of this act shall be the
17 Mayor of Lelu Town Government or his designee; the
18 allottee of funds appropriated under subsections
19 4(2)(a), 4(2)(e), 4(2)(f), 4(2)(g), 4(2)(h), 4(2)(k),
20 4(2)(q), 4(2)(r), 4(3)(s), 4(3)(b), 4(3)(f), ~~4(3)(j)~~,
21 4(3)(k), ~~4(3)(o)~~, 4(3)(p), 4(3)(r) and 4(3)(s) of this
22 act shall be the Pohnpei Transportation Authority (PTA);
23 the allottee of funds appropriated under subsection
24 4(2)(c), 4(2)(d), 4(2)(i), 4(2)(j) 4(3)(a), 4(3)(c),
25 4(3)(d), 4(3)(i), 4(2)(t), 4(3)(d) ~~and~~ 4(3)(q)

1 4(3)(o) and 4(3)(t) of this act shall be the Secretary
2 of the Department of Transportation, Communications and
3 Infrastructure or his designee; the allottee of funds
4 appropriated under subsection 4(2)(b) of this act shall
5 be the President of COM-FSM; the allottee of funds
6 appropriated under subsections 4(2)(m), 4(2)(n), 4(2)(o)
7 and 4(2)(p) of this act shall be the Mayor of Sapuwahfik
8 Municipal Government or his designee; the allottee of
9 funds appropriated under subsections 4(3)(e), 4(3)(l),
10 4(3)(m) and 4(3)(n) of this act shall be the Meninkeder
11 Laplap; the allottee of funds appropriated under
12 subsection 4(3)(h) of this act shall be the Chief
13 Justice of Kitti Municipal Government, or his designee;
14 the allottee of funds appropriated under subsections
15 4(2)(l), 4(2)(s), and 4(3)(g) of this act shall be the
16 Pohnpei Utility Corporation. The allottee of the funds
17 appropriated under subsection 4(3)(j) of this act shall
18 be the President of the COM-FSM or her designee. The
19 allottee of the funds appropriated under subsections
20 5(1) and 5(6) of this act shall be the Governor of Chuuk
21 State or his designee; the allottee of the funds
22 appropriated under subsection 5(2) of this act shall be
23 the Mortlocks Island Development Authority (MIDA); the
24 allottee of the funds appropriated under subsection 5(3)
25 of this act shall be the Mayor of Weno Municipal

1 Government or his designee; the allottee of the funds
2 appropriated under subsection 5(4) of this act shall be
3 the Southern Namoneas Development Authority; the
4 allottee of the funds appropriated under subsection 5(5)
5 of this act shall be the Faichuk Development Authority.
6 The authority of the allottee to obligate funds
7 appropriated by this act shall lapse on September 30,
8 [2025] 2027."

9 Section 3. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its
11 becoming law without such approval.
