

A BILL FOR AN ACT

To amend Public Law No. 22-157, as amended by Public Laws No. 22-179, 23-91 and 23-141, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 22-157, as amended
2 by Public Laws Nos. 22-197 and 23-141, is hereby further amended
3 to read as follows:

4 "Section 4. Of the \$2,800,000 appropriated under this
5 act, \$800,000 shall be apportioned for public projects
6 and social programs for the people of Pohnpei State.

25	Section 2. Section 6 of Public Law No. 22-157, as amended by	

1 Public Laws Nos. 22-179 and 23-91, is hereby further amended to
2 read as follows:

3 “Section 6. Allotment and management of funds and lapse
4 date. All funds appropriated by this act shall be
5 allotted, managed, administered and accounted for in
6 accordance with applicable laws, including, but not
7 limited to, the Financial Management Act of 1979. The
8 allottee shall be responsible for ensuring that these
9 funds, or so much thereof as may be necessary, are used
10 solely for the purpose specified in this act, and that
11 no obligations are incurred in excess of the sum
12 appropriated. The allottee of the funds appropriated
13 under section 2 of this act shall be the Governor of Yap
14 State or his designee. The allottee of funds
15 appropriated under sections 3 and 4 of this act shall be
16 the President of the Federated States of Micronesia or
17 his designee; EXCEPT THAT, the allottee of funds
18 appropriated under section 3(1) of this act shall be the
19 Governor of Kosrae State or his designee; the allottee
20 of funds appropriated under section 3(2) of this act
21 shall be the Mayor of Lelu Town Government or his
22 designee; the allottee of funds appropriated under
23 subsections 4(1)a, 4(1)(b), 4(1)(c), 4(2)(a), 4(2)(b),
24 4(2)(d), 4(2)(g), 4(2)(i) [~~and~~], 4(3)(c), 4(3)(e) and
25 4(3)(k) of this act shall be the Secretary of the

1 Department of Transportation, Communications and
2 Infrastructure or his designee; the allottee of funds
3 appropriated under subsections 4(2)(c) and 4(3)(b) of
4 this act shall be the Secretary of Health and Social
5 Affairs or her designee; the allottee of funds
6 appropriated under subsection 4(2)(e) of this act shall
7 be the President of COM-FSM; the allottee of funds
8 appropriated under subsection 4(2)(f) of this act shall
9 be the FSM NOC; the allottee of funds appropriated under
10 subsections 4(1)(d), 4(1)(e), 4(2)(h) of this act shall
11 be the Secretary of the Department of Education or his
12 designee; the allottee of funds appropriated under
13 subsections 4(3)(a), 4(3)(d), [~~4(3)(e)~~], 4(3)(f) and
14 4(3)(g) of this act shall be the Pohnpei Transportation
15 Authority (PTA); the allottee of funds appropriated
16 under subsections 4(3)(h) of this act shall be the
17 Pohnpei Utility Corporation (PUC); the allottee of funds
18 appropriated under sections 4(3)(j) and 4(3)(n) of this
19 act shall be the Meninkeder Lapalap of Madolenihmw; the
20 allottee of funds appropriated under [~~sections 4(3)(k)~~
21 ~~and~~] section 4(3)(m) of this act shall be the Vice
22 President of the Federated States of Micronesia or his
23 designee; the allottee of funds appropriated under
24 section 4(3)(l) of this act shall be the Secretary of
25 the Department of Education or his designee;. The

1 allottee of the funds appropriated under subsections
2 5(1) and 5(6) of this act shall be the Governor of Chuuk
3 State or his designee; the allottee of the funds
4 appropriated under subsection 5(2) of this act shall be
5 the Mortlocks Island Development Authority (MIDA); the
6 allottee of the funds appropriated under subsection 5(3)
7 of this act shall be the Mayor of Weno Municipal
8 Government or his designee; the allottee of the funds
9 appropriated under subsection 5(4) of this act shall be
10 the Southern Namoneas Development Authority; the
11 allottee of the funds appropriated under subsection 5(5)
12 of this act shall be the Faichuk Development Authority.
13 The authority of the allottee to obligate funds
14 appropriated by this act shall lapse on September 30,
15 2026."

16 Section 3. This act shall become law upon approval by the
17 President of the Federated States of Micronesia or upon its
18 becoming law without such approval.
