
A BILL FOR AN ACT

To appropriate the sum of \$2,100,000 from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2025, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk states, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. The sum of \$2,100,000, or so much thereof as
2 may be necessary, is hereby appropriated from the General Fund
3 of the Federated States of Micronesia for the fiscal year ending
4 September 30, 2025, for the purpose of funding public projects
5 and social programs for the people of Yap, Kosrae, Pohnpei and
6 Chuuk states. The funds appropriated under this section shall
7 be apportioned as follows:

8 Section 2. Of the \$2,100,000 appropriated under this act,
9 \$300,000 shall be apportioned to fund public projects and
10 social programs for the people of Yap.

12 Section 3. Of the \$2,100,000 appropriated under this act,
13 \$300,000 shall be apportioned to fund public projects and
14 social programs for the people of Kosrae.

15 state of Kosrae..... 300,000

16 (1) At large..... 150,000

17 (2) Election District No. 1 150,000

1 Section 4. Of the \$2,100,000 appropriated under this act,
2 \$600,000 shall be apportioned to fund public projects and
3 social programs for the people of Pohnpei.

9 Section 5. Of the \$2,100,000 appropriated under this act,
10 \$900,000 shall be apportioned to fund public projects and
11 social programs for the people of Chuuk.

19 Section 6. Allotment and management of funds and lapse
20 date. All funds appropriated by this act shall be allotted,
21 managed, administered and accounted for in accordance with
22 applicable laws, including, but not limited to, the Financial
23 Management Act of 1979. The allottee shall be responsible for
24 ensuring that these funds, or so much thereof as may be
25 necessary, are used solely for the purpose specified in this

1 act, and that no obligations are incurred in excess of the sum
2 appropriated. The allottee of the funds appropriated under
3 section 2 of this act shall be the Governor of Yap or his
4 designee. The allottee of the funds appropriated under
5 subsection 3(1) of this act shall be the Governor of Kosrae or
6 his designee. The allottee of the funds appropriated under
7 subsection 3(2) of this act shall be the Mayor of Lelu Town
8 Government or his designee. The allottee of the funds
9 appropriated under section 4 of this act shall be the President
10 of the Federated States of Micronesia or his designee. The
11 allottee of the funds appropriated under subsections 5(1) and
12 5(6) of this act shall be the Governor of Chuuk State or his
13 designee; the allottee of the funds appropriated under
14 subsection 5(2) of this act shall be the Mortlocks Island
15 Development Authority (MIDA); the allottee of the funds
16 appropriated under subsection 5(3) of this act shall be the
17 Mayor of Weno Municipal Government or his designee; the allottee
18 of the funds appropriated under subsection 5(4) of this act
19 shall be the Southern Namoneas Development Authority; the
20 allottee of the funds appropriated under subsection 5(5) of this
21 act shall be the Faichuk Development Authority. The authority
22 of the allottee to obligate funds appropriated by this act shall
23 lapse on September 30, 2027.

1 Section 7. This act shall become law upon approval by the
2 President of the Federated States of Micronesia or upon its
3 becoming law without such approval.
