A RESOLUTION

To approve and accept a grant in the amount of USD \$3,600,000 from the Australian Government, for funding the implementation of the outer islands electrification and renewable energy projects, through the partnership between the National Government of the Federated States of Micronesia and the Pacific Community, including terms and conditions of the assistance.

- 1 WHEREAS, the Australian Government, through its Department of
- 2 Foreign Affairs and Trade, has awarded a grant totaling AUD 5.8
- 3 million (USD 3.6 million) to the Pacific Community, to fund
- 4 renewable energy and electrification projects aimed at providing
- 5 accessible and sustainable electricity to the outer islands of the
- 6 Federated States of Micronesia; and
- 7 WHEREAS, the FSM Government and the Pacific Community have
- 8 entered into a partnership agreement, funded by the Australian
- 9 Government, to jointly implement the outer islands electrification
- 10 and renewable energy projects in the states of Chuuk, Yap, and
- 11 Pohnpei; and
- 12 WHEREAS, the implementation of the project will be carried
- 13 out in accordance with the DFAT-SPC signed grant agreements, with
- 14 the first agreement covering electrification in Piis Paneu in
- 15 Chuuk and the second agreement covering renewable energy projects
- 16 in Woleai in Yap, and Pingelap in Pohnpei; and
- 17 WHEREAS, the FSM Department of Resources and Development will
- 18 support and facilitate the Pacific Communities effective delivery

1 of the projects through financial oversight, logistical support,

- 2 and coordination; and
- 3 WHEREAS, section 210(2) of title 55 of the Code the Federated
- 4 States of Micronesia (Annotated), as amended, requires that for
- 5 foreign financial assistance to be valid it must be approve by
- 6 Congress by resolution, and
- 7 WHEREAS, the Government of the Federated States of Micronesia
- 8 wishes to express its appreciation and gratitude to the
- 9 Government of Australian for improving renewable energy access in
- 10 the FSM, now, therefore,
- BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
- 12 States of Micronesia, First Special Session, 2025, that Congress
- 13 hereby approves and accepts the USD \$3,600,000 grant from the
- 14 Australian Government, through the partnership between the FSM
- 15 Government and the Pacific Community, for the outer islands
- 16 electrification and renewable energy projects, including all the
- 17 terms and conditions thereof; and
