Dear Speaker:

Your Committee on External Affairs, to which was referred Congressional Resolution No. 24-38, entitled:

"A RESOLUTON TO CONFIRM THE NOMIATION OF MR. JOHNNY M. SILBANUZ TO SERVE AS THE FSM CONSUL GENERAL IN GUAM, U.S.A.",

begs leave to report as follows:

The intent and purpose of this resolution are expressed in its title.

Mr. Johnny M. Silbanuz has been nominated by the President of the Federated States of Micronesia to serve as the FSM Consul General in Guam. Article X, section 2(d) of the Constitution of the Federated States of Micronesia and title 2, section 207 of the Code of the Federated States of Micronesia (Annotated), provides that this nomination is subject to the advice and consent of the Congress of the Federated States of Micronesia.

EDUCATION AND PROFESSIONAL EXPERIENCE

Presidential Communication No. 24-85 accompanied C.R. No. 24-38 and included Mr. Johnny M. Silbanuz's CV. Mr. Silbanuz is originally from Pohnpei State. He attended high school at Pohnpei Island Central School (PICS). He then attended the College of Micronesia where he earned an Associate of Science degree in Hotel and Tourism Management. Mr. Silbanuz then attended the University of Guam earning his Bachelor of Arts in International Tourism and Hospitality and his Master's degree in Public Administration.

Mr. Silbanuz spent several years working in the tourism industry before graduating with his Master's degree. He then worked one year as the Climate Change Coordinator for the Secretariate of the Pacific Community/FSM Office of Environmental and Emergency Management. Mr. Silbanuz spent the next decade, from 2013-2023, as a Foreign Service Officer in the Consulate of the Federated States of Micronesia in Guam. In September of 2023, he was tapped to be the Acting Consul General of the Consulate of the Federated States of Micronesia in Guam. He is serving in that capacity currently.

Mr. Silbanuz has served the Consulate of the Federated States of Micronesia in Guam for over a decade. Your Committee finds Mr. Silbanuz's educational and professional achievements relevant and suitable for the FSM Consul General in Guam.

CONCLUSION

Upon review of the nominee and his qualifications your Committee is satisfied that the nominee is fit for service as the FSM Consul General in Guam.

Therefore, your Committee on External Affairs recommends Mr. Johnny M. Silbanuz be confirmed to serve as the FSM Consul
