Your Committee heard testimony from the various divisions as to their requests under grants, subsidies, and contributions. Your Committee notes that in light of the states now receiving 50% of the fishing fees, any request made that is for a state entity or for a joint state/national program has been reduced by 50%. Your Committee encourages the states to fund the remaining portion of these requests.

Your Committee based on the testimony it heard, reduced the requests by the EBRC for the following:

Victim Shelter Services from \$100,000 to \$50,000. Your Committee heard no testimony to justify an 100% increase from FY25 to FY26.

Police Academy Facility from \$500,000 to \$0. Your Committee notes that DOJ did not propose this in their submission to the EBRC. This request was added by the EBRC and there was no testimony as to why this was needed nor why it is needed in this fiscal year.

A&P Legal Services from \$500,000 to \$0. Your Committee notes that the current contract with Arnold & Porter runs through mid-October 2025. It is premature at this time to speculate as to the Executive's decision to continue to utilize A&P past the current contract.
