To further amend Public Law No. 18-99, as amended by Public Laws Nos. 18-106, 18-113, 18-121, 19-05, 19-34, 19-57, 19-74, 19-107, 20-18, 20-24, 20-80, 20-112, 21-28, 21-106, 21-131, 21-177, 22-129 and 23-81, by amending sections 4 and 6 thereof, to change the allottee and use of funds previously appropriated therein, to fund public projects and social programs for the people of the states of Yap, Kosrae, Pohnpei and Chuuk, and for other purposes.

2	solely for the purpose specified in this act, and that
3	no obligations are incurred in excess of the sum
4	appropriated. The allottee of the funds appropriated
5	under section 2 of this act shall be the Governor of Yap
6	State or his designee. The allottee of funds
7	appropriated under section 3 shall be the President or
8	his designee, EXCEPT THAT the allottee of funds
9	appropriated under section 3(a), (b), (c), (d), (e),
10	(f), (g), (h), (i), (j), (k), (l), (m), (n), (o), (u)
11	and (y) shall be the Mayor of Lelu Town Government. The
12	allottee of funds appropriated under section 4 of this
13	act shall be the President or his designee, EXCEPT that
14	the allottee of funds appropriated under section 4(1)(a)
15	shall be the Secretary of the Department of Education;
16	the allottee of funds appropriated under sections
17	4(1)(c), 4(1)(e), 4(1)(h), 4(2), 4(3)(a), and 4(3)(b) to
18	4(3)(j) shall be Secretary of the Department of
19	Transportation, Communications and Infrastructure or his
20	designee; the allottee of funds appropriated under
21	section 4(1)(d) shall be the Pohnpei Port Authority; the
22	allottee of funds appropriated under section 4(1)(f)
23	shall be the Nett District Government; the allottee of
24	funds appropriated under section 4(1)(g) shall be the
25	Secretary of the Department of Resources and

1	Development. The allottee of funds appropriated under
2	section 4(3)(k) shall be the Secretary of the Department
3	of Health and Social Affairs or his designee. The
4	allottee of funds appropriated under sections 5(1) and
5	5(6) of this act shall be the Governor of Chuuk State or
6	his designee. The allottee of funds appropriated under
7	subsection 5(2) of this act shall be the Mortlock
8	Islands Development Authority. The allottee of funds
9	appropriated under subsection 5(3) of this act shall be
10	the Mayor of Weno Municipal Government or his designee.
11	The allottee of funds appropriated under subsection 5(4)
12	of this act shall be the Southern Namoneas Development
13	Authority. The allottee of funds appropriated under
14	subsection 5(5) of this act shall be the Faichuk
15	Development Authority. The authority of the allottee to
16	obligate funds appropriated by this act shall lapse on
17	September 30, 2026."
