CONGRESSIONAL RESOLUTION NO. 24-37

A RESOLUTION

To confirm the nomination of Mr. Lucas M. Cupps to serve as the Independent Prosecutor of the Office of the Independent Prosecutor of the Federated State of Micronesia.

1 WHEREAS, pursuant to Congressional Resolution No. 24-23, the
2 President of the Federated States of Micronesia is authorized to
3 resubmit the nomination of Mr. Lucas M. Cupps to serve as the
4 Independent Prosecutor of the Office of the Independent Prosecutor
5 of the Federated States of Micronesia; and

6 WHEREAS, Mr. Cupps obtained his Juris Doctorated from Yale
7 Law School in New Haven, Connecticut; and

8 WHEREAS, Mr. Cupps is qualified to serve as the Independent
9 Prosecutor based on his education background and years of
10 experience including as a staff attorney for the Congress of the
11 Federated States of Micronesia from 2015-2017, and is employed
12 currently as an attorney at Ramp & Mida Law Firm; and

13 WHEREAS, the nomination and appointment requires the advice
14 and consent of the Congress of the Federated States of Micronesia
15 pursuant to Article X, Section 2(d) of the Constitution of the
16 Federated States of Micronesia; now, therefore,

17 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
18 States of Micronesia, Second Regular Session, 2025, that Congress
19 hereby confirms the nomination of Mr. Lucas M. Cupps to serve as
20 the Independent Prosecutor of the Office of the Independent

1 Prosecutor of the Federated States of Micronesia; and

2 BE IT FURTHER RESOLVED that certified copies of this
3 resolution be transmitted to the President of the Federated
4 States of Micronesia, the Secretary of the Department of Justice,
5 and Mr. Lucas M. Cupps.


