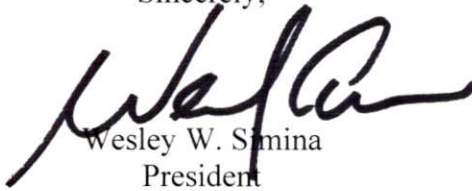

AN ACT

To further amend Public Law No. 22-186, as amended by Public Laws Nos. 22-189, 23-01, 23-14, 23-47, 23-73, 23-107, 23-126, and 23-169, by amending sections 4 and 6 thereof, to change the use, allottee, and lapse date of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 22-186, as amended by
2 Public Laws Nos. 22-189, 23-01, 23-47, 23-73, 23-107, 23-126 and
3 23-169, is hereby further amended to read as follows:

4 "Section 4. Of the \$5,600,000 appropriated under this
5 act, \$1,600,000 shall be apportioned for public projects
6 and social programs for the people of Pohnpei State.

16 Section 2. Section 6 of Public Law No. 22-186, as amended by
 17 Public Laws Nos. 22-189, 23-47 and 23-72, is hereby further
 18 amended to read as follows:

19 "Section 6. Allotment and management of funds and lapse
 20 date. All funds appropriated by this act shall be
 21 allotted, managed, administered and accounted for in
 22 accordance with applicable laws, including, but not
 23 limited to, the Financial Management Act of 1979. The
 24 allottee shall be responsible for ensuring that these
 25 funds, or so much thereof as may be necessary, are used

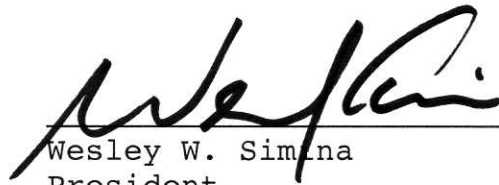
1 solely for the purpose specified in this act, and that
2 no obligations are incurred in excess of the sum
3 appropriated. The allottee of the funds appropriated
4 under section 2 of this act shall be the Governor of Yap
5 State or his designee; EXCEPT THAT the allottee of funds
6 appropriated under section 2(i) of this act shall be the
7 President of the Federated States of Micronesia or his
8 designee. The allottee of funds appropriated under
9 sections 3 and 4 of this act shall be the President of
10 the Federated States of Micronesia or his designee;
11 EXCEPT THAT, the allottee of funds appropriated under
12 section 3(1) of this act shall be the Governor of Kosrae
13 State or his designee; the allottee of funds
14 appropriated under section 3(2) of this act shall be the
15 Mayor of Lelu Town Government or his designee; the
16 allottee of funds appropriated under subsections
17 4(2)(a), 4(2)(e), 4(2)(f), 4(2)(g), 4(2)(h), 4(2)(k),
18 4(2)(q), 4(2)(r), 4(3)(s), 4(3)(b), 4(3)(f), 4(3)(k),
19 4(3)(p), 4(3)(r) and 4(3)(s) of this act shall be the
20 Pohnpei Transportation Authority (PTA); the allottee of
21 funds appropriated under subsection 4(2)(c), 4(2)(d),
22 4(2)(i), 4(2)(j) 4(3)(a), 4(3)(c), 4(3)(d), 4(3)(i),
23 4(2)(t), 4(3)(d), 4(3)(q), 4(3)(o), 4(3)(t) and 4(a)(u)
24 of this act shall be the Secretary of the Department of
25 Transportation, Communications and Infrastructure or his

1 designee; the allottee of funds appropriated under
2 subsection 4(2)(b) of this act shall be the President of
3 COM-FSM; the allottee of funds appropriated under
4 subsections 4(2)(m), 4(2)(n), 4(2)(o) and 4(2)(p) of
5 this act shall be the Mayor of Sapuwahfik Municipal
6 Government or his designee; the allottee of funds
7 appropriated under subsections 4(3)(e), 4(3)(l), 4(3)(m)
8 and 4(3)(n) of this act shall be the Meninkeder Lapalap;
9 the allottee of funds appropriated under subsection
10 4(3)(h) of this act shall be the Chief Justice of Kitti
11 Municipal Government or his designee; the allottee of
12 funds appropriated under subsection 4(3)(g) of this act
13 shall be the Speaker of Kitti Municipality Government or
14 his designee; the allottee of funds appropriated under
15 subsections 4(2)(l) and 4(2)(s) of this act shall be the
16 Pohnpei Utility Corporation. The allottee of the funds
17 appropriated under subsection 4(3)(j) of this act shall
18 be the President of COM-FSM or her designee. The
19 allottee of the funds appropriated under subsections
20 5(1) and 5(6) of this act shall be the Governor of Chuuk
21 State or his designee; the allottee of the funds
22 appropriated under subsection 5(2) of this act shall be
23 the Mortlocks Island Development Authority (MIDA); the
24 allottee of the funds appropriated under subsection 5(3)
25 of this act shall be the Mayor of Weno Municipal

1 Government or his designee; the allottee of the funds
2 appropriated under subsection 5(4) of this act shall be
3 the Southern Namoneas Development Authority; the
4 allottee of the funds appropriated under subsection 5(5)
5 of this act shall be the Faichuk Development Authority.
6 The authority of the allottee to obligate funds
7 appropriated by this act shall lapse on September 30,
8 2027."

9 Section 3. This act shall become law upon approval by the
10 President of the Federated States of Micronesia or upon its
11 becoming law without such approval.
