AN ACT

To further amend Public Law No. 20-31, as amended by Public Laws Nos. 20-41, 20-50, 20-77, 20-113, 21-24, 21-45, 21-83, 21-101, 21-133, 21-204, 21-220, 22-79, 22-113, 22-150, 23-65, 23-136, 23-165 and 24-08, by amending sections 4 and 6 thereof, to change the use and allottee of certain funds previously appropriated therein, to fund public projects and social programs for the people of Pohnpei State, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 4 of Public Law No. 20-31, as amended by

Section 2. Section 6 of Public Law No. 20-31, as amended by 2 Public Laws Nos. 20-41, 21-24, 21-83, 21-133, 21-204, 22-113, 3 23-65 and 24-08, is hereby further amended to read as follows: "Section 6. Allotment and management of funds and 5 lapse date. All funds appropriated by this act shall be allotted, managed, administered and accounted for 6 in accordance with applicable laws, including, but not 7 limited to, the Financial Management Act of 1979. 8 9 allottee shall be responsible for ensuring that these 10 funds, or so much thereof as may be necessary, are 11 used solely for the purpose specified in this act, and 12 that no obligations are incurred in excess of the sum 13 appropriated. The allottee of the funds appropriated 14 under section 2 of this act shall be the Governor of 15 Yap State or his designee. The allottee of funds appropriated under sections 3 and 4 of this act shall 16 17 be the President of the Federated States of Micronesia 18 or his designee; PROVIDED THAT the allottee of funds 19 appropriated under subsections 3(a) to 3(n) of this 20 act shall be the Mayor of Lelu Town Government or his 21 designee; the allottee of funds appropriated under 22 subsections 3(o) to 3(ae) of this act shall be the 23 Governor of Kosrae State or his designee; the allottee 24 of funds appropriated under subsections 4(1)(f), 25 4(1)(k), 4(1)(1), 4(1)(m), 4(2)(b), 4(2)(c) and

1	4(3)(y) of this act shall be the Pohnpei
2	Transportation Authority (PTA); the allottee of funds
3	appropriated under subsections 4(2)(a), 4(2)(d),
4	4(2)(e), $4(2)(f)$, $4(2)(g)$, $4(2)(h)$, $4(2)(i)$ and
5	4(2)(j) shall be the Secretary of the Department of
6	Transportation, Communications and Infrastructure or
7	his designee; $4(3)(g)$, $4(3)(v)$ and $4(3)(w)$ of this act
8	shall be the Secretary of Education or his designee;
9	the allottee of funds appropriated under subsections,
10	4(3)(1) and $4(3)(t)$ of this act shall be the
11	Luhkenmoanlap of Kitti; the allottee of funds
12	appropriated under subsection 4(3)(o) of this act
13	shall be the Pohnpei Utility Corporation; the allottee
14	of funds appropriated under subsection 4(3)(j) of this
15	act shall be the Speaker of Madolenihmw Municipal
16	Government or his designee; the allottee of funds
17	appropriated under subsection 4(3)(p) of this act
18	shall be the Director of Land Grant Program; the
19	allottee of funds appropriated under subsection
20	4(3)(r) of this act shall be the Secretary of Health
21	and Social Affairs or her designee; the allottee of
22	funds appropriated under subsection 4(3)(u) of this
23	act shall be the Meninkeder of Madolenihmw. The
24	allottee of funds appropriated under subsection
25	4(3)(z) of this act shall be the Chief Justice of

1	Madolenhimw Municipal Government or his designee. The
2	allottee of funds appropriated under subsection 5(1)
3	and 5(6) of this act shall be the Governor of Chuuk
4	State or his designee. The allottee of funds
5	appropriated under subsection 5(2) of this act shall
6	be the Mortlock Islands Development Authority. The
7	allottee of funds appropriated under subsection 5(3)
8	of this act shall be the Mayor of Weno Municipal
9	Government or his designee. The allottee of funds
10	appropriated under subsection 5(4) of this act shall
11	be the Southern Namoneas Development Authority. The
12	allottee of funds appropriated under subsection 5(5)
13	of this act shall be the Faichuk Development
14	Authority. The authority of the allottee to obligate
15	funds appropriated by this act shall lapse on
16	September 30, 2026."
