AN ACT

To further amend Public Law No. 19-54, as amended by Public Laws Nos. 19-62, 19-75, 19-79, 19-99, 19-119, 20-04, 20-56, 20-82, 20-127, 21-20, 21-117, 21-169, 21-174, 21-194, 21-205, 21-233, 22-15, 22-54, 22-109, 23-52 and 23-85, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, to fund public projects and social programs in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1	Section 1. Section 4 of Public Law No. 19-54, as amended

8	by Public Laws Nos. 19-62, 19-75, 19-99, 19-129, 20-04, 20-127,
9	21-20, 21-117, 22-15, 22-109 and 23-85, is hereby further
10	amended to read as follows:
11	"Section 6. Allotment and management of funds and lapse
12	date. All fund appropriated by this act shall be
13	allotted, managed, administered and accounted for in
14	accordance with applicable laws including, but not
15	limited to, the applicable laws, including, but not
16	limited to, the Financial Management Act of 1979. The
17	allottee shall be responsible for ensuring that these
18	funds, or so much thereof as may be necessary, are used
19	solely for the purpose specified in this act, and that
20	no obligations are incurred in excess of the sum
21	appropriated. The allottee of the funds appropriated
22	under section 2 of this act shall be the Governor of Yap
23	State. The allottee of funds appropriated under
24	sections 3 and 4 of this act shall be the President of
25	the Federated States of Micronesia or his designee;

1 PROVIDED THAT, the allottee of funds appropriated under 2 subsections 3(a), (b), (c), (d), (e), (f), (g), (h), 3 (t), (u), (v), (ag), (ar) and (as) of this act shall be the Mayor of Utwe Municipal Government or his designee; 4 the allottee of funds appropriated under subsections 5 6 3(k), (w), (x), (y), (z), (aa), (ab), (ac), (ad), (ae), (af), (ah), (ai), (aj), (ak), (al), (am), (an), (ao), 7 (ap) and (aq) of this act shall be the Mayor of Tafunsak 8 Municipal Government or his designee; the allottee of 9 funds appropriate under subsections 4(1)(a), (b), (c), 10 11 (e), (f), 4(2), 4(3)f) and 4(3)(aa) shall be the Secretary of the Department of Transportation, 12 13 Communications and Infrastructure or his designee; the allottee of funds appropriated under subsections 14 4(1)(d), 4(3)(b), 4(3)(d), 4(3)(e), 4(3)(h), 4(3)(k), 15 4(3)(1) and 4(3)(y) shall be the Pohnpei Transportation 16 Authority (PTA). The allottee of fund appropriated under 17 18 subsection 4(3)(z) of this act shall be the Pohnpei Utility Corporation. The allottee of funds appropriated 19 under subsections 5(1) and 5(6) of this act shall be the 20 21 Governor of Chuuk State or his designee. The allottee 22 of funds appropriated under subsection 5(2) of this act 23 shall be the Mortlock Islands Development Authority. 24 The allottee of funds appropriated under subsection 5(3) 25 of this act shall be the Mayor of Weno Municipal

1	Government or his designee. The allottee of funds
2	appropriated under subsection 5(4) of this act shall be
3	the Southern Namoneas Development Authority. The
4	allottee of funds appropriated under subsection 5(5) of
5	this act shall be the Faichuk Development Authority.
6	The authority of the allottee to obligate funds
7	appropriated by this act shall lapse on September 30,
8	2026."
9	Section 3. This act shall become law upon approval by the
10	President of the Federated States of Micronesia or upon its
11	becoming law without such approval.
