A BILL FOR AN ACT

To amend title 54 of the Code of the Federated States of Micronesia (Annotated), as amended, by amending section 221 thereof, to adjust the rates of certain import duties, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

- 1 Section 1. Section 221 of title 54 of the Code of the
- 2 Federated States of Micronesia (Annotated), as amended, is hereby
- 3 amended to read as follows:
- 4 "Section 221. Levy and rates.
- 5 The following import duties are hereby levied on all
- 6 products specified herein which are imported into the
- 7 FSM:
- 8 (1) cigarettes, at the rate of \$0.025 per cigarette,
- 9 provided that this rate shall increase by \$0.005 per
- 10 cigarette on January 1 of each of the years 2007, 2009,
- 11 2011, 2013 and 2015;
- 12 (2) tobacco, other than cigarettes, at the rate of 50
- 13 percent ad valorem;
- 14 (3) perfumery, [cosmetics, and toiletries,] including
- 15 cologne and other toilet waters, and articles of
- 16 perfumery, whether in sachets or otherwise, and all
- 17 [preparations used as applications to the hair or skin,
- 18 lipsticks, pomades, powders, and other toilet
- 19 <u>preparations not having medicinal properties</u>] non-
- 20 medicinal haircare, skincare, and makeup products, at

the rate of 25 percent ad valorem; provided, however, 1 2 that all personal hygienic products, including but not limited to oral health products, at the rate of four 3 4 percent ad valorem; (4) soft drinks, drink mixes, drink preparations, 5 6 coffee, tea, and nonalcoholic beverages, at the rate of 7 25 percent ad valorem[-]; provided, however, that any beverage having a fruit juice content of 25 percent or 8 9 more by volume shall be at the rate of three percent ad 10 valorem; and provided further, that sakau, sakau powder, and sakau roots, in any form and regardless of 11 preparation, shall be at the rate of four percent ad 12 13 valorem; 14 (5) beer and malt beverages, at the rate of \$0.25 per 12 fluid ounces; 15 16 (6) distilled alcoholic beverages, at the rate of 12 dollars per gallon; 17 (7) wine at the rate of 30 percent ad valorem; 18 19 (8) foodstuffs for human consumption, at the rate of 20 three percent ad valorem; provided, however, that fresh 21 and frozen fish and seafood, shall be at the rate of 25 percent ad valorem; 22 23 (9) gasoline and diesel fuel, at the rate of five cents 24 per gallon; 25 (10) laundry bar soap, at the rate of 25 percent ad
