

A BILL FOR AN ACT

To amend Public Law No. 24-40, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein to fund public projects and social programs for the people of Pohnpei state, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 24-40 is hereby
2 amended to read as follows:
3 "Section 4. Of the \$2,100,000 appropriated under this
4 act, \$600,000 shall be apportioned to fund public projects and
5 social programs for the people of Pohnpei.

1 Section 2. Section 6 of Public Law No. 24-40 is hereby
2 amended to read as follows:

3 “Section 6. Allotment and management of funds and lapse
4 date. All funds appropriated by this act shall be allotted,
5 managed, administered and accounted for in accordance with
6 applicable laws, including, but not limited to, the Financial
7 Management Act of 1979. The allottee shall be responsible for
8 ensuring that these funds, or so much thereof as may be
9 necessary, are used solely for the purpose specified in this
10 act, and that no obligations are incurred in excess of the sum
11 appropriated. The allottee of the funds appropriated under
12 section 2 of this act shall be the Governor of Yap or his
13 designee. The allottee of the funds appropriated under
14 subsection 3(2) of this act shall be the Mayor of Lelu Town
15 Government or his designee. The allottee of the funds
16 appropriated under section 4 of this act shall be the President
17 of the Federated States of Micronesia or his designee. The
18 allottee of funds appropriated under section 3(1) of this act
19 shall be the Mayor of Malem Municipal Government or his
20 designee. The allottee of funds appropriated under sections
21 4(2) [~~4(3)(a), 4(3)(b), 4(3)(c),~~] 4(3)(d), 4(3)(e) and 4(4)(d)
22 of this act shall be the Secretary of the Department of
23 Transportation, Communications and Infrastructure or his
24 designee. The allottee of funds appropriated under subsections
25 4(3)(a), 4(3)(b) and 4(3)(c) shall be the Pohnpei Transportation

1 Authority (PTA). The allottee of the funds appropriated under
2 subsections 5(1) and 5(6) of this act shall be the Governor of
3 Chuuk State or his designee; the allottee of the funds
4 appropriated under subsection 5(2) of this act shall be the
5 Mortlocks Island Development Authority (MIDA); the allottee of
6 the funds appropriated under subsection 5(3) of this act shall
7 be the Mayor of Weno Municipal Government or his designee; the
8 allottee of the funds appropriated under subsection 5(4) of this
9 act shall be the Southern Namoneas Development Authority; the
10 allottee of the funds appropriated under subsection 5(5) of this
11 act shall be the Faichuk Development Authority. The authority of
12 the allottee to obligate funds appropriated by this act shall
13 lapse on September 30, 2028.

14 Section 3. This act shall become law upon approval by the
15 President of the Federated States of Micronesia or upon its
16 becoming law without such approval.
