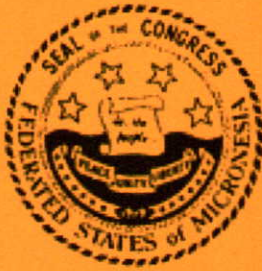

14 therefore,


15 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
