A RESOLUTION

Approving and accepting a grant in the amount of \$908,299 from the United States Department of Health and Human Services, Centers for Disease Control and Prevention, to accelerate the prevention and control of HIV, Viral Hepatitis, Sexually Transmitted Disease, and Tuberculosis in the Federated States of Micronesia, including all the terms and conditions of the assistance.

1        WHEREAS, the United States Department of Health and Human  
2 Services, Centers for Disease Control and Prevention, extended to  
3 the Government of the Federated States of Micronesia a grant in  
4 the amount of \$908,229, through a Notice of Award dated January  
5 05, 2026; and

6        WHEREAS, the purpose of the grant is to accelerate the  
7 prevention and control of HIV, Viral Hepatitis, Sexually  
8 Transmitted Disease, and Tuberculosis in the Federated States of  
9 Micronesia for the budget period from January 1, 2026, to December  
10 31, 2026; and

11       WHEREAS, section 210(2) of title 55 of the Code of the  
12 Federated States of Micronesia (Annotated), as amended, requires  
13 that for foreign financial assistance to be valid it must be  
14 approved by Congress by resolution; now, therefore,

15       BE IT RESOLVED by the Twenty-Fourth Congress of the Federated  
16 States of Micronesia, Third Regular Session, 2026, that Congress  
17 hereby approves and accepts the \$908,299 grant from the United  
18 States Department of Health and Human Services, Centers for

1 Disease Control and Prevention, including all the terms and  
2 conditions thereof; and

3 BE IT FURTHER RESOLVED that certified copies of this  
4 resolution be transmitted to the President of the Federated States  
5 of Micronesia, the Secretary of the Department of Health and  
6 Social Affairs, and the Secretary of the Department of Justice.


