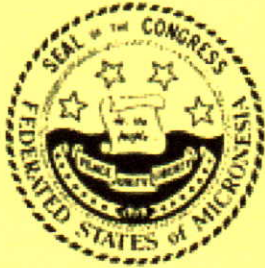

INCLUDING ALL THE TERMS AND CONDITIONS OF THE ASSISTANCE.

A RESOLUTION

To approve and accept a grant in the amount of \$47,500 from the Multilateral Fund (MLF) to support the additional activities to maintain Energy Efficiency in the Refrigeration Servicing Sector, including all the terms and conditions of the assistance.

1 WHEREAS, the Multilateral Fund issued a Grant Award on
2 September 25, 2025, to the Government of the Federated States of
3 Micronesia providing funding in the amount of \$47,500 for the
4 purpose of providing support to the FSM to implement the
5 additional activities to maintain Energy Efficiency in the
6 Refrigeration Servicing Sector; and

7 WHEREAS, section 210(2) of title 55 of the Code of the
8 Federated States of Micronesia (Annotated), as amended, requires
9 that for foreign financial assistance to be valid it must be
10 approved by Congress by resolution; and

11 WHEREAS, that the Government of the Federated States of
12 Micronesia wishes to express its appreciation and gratitude to
13 the Multilateral Fund for extending this grant; now,
14 therefore,

15 BE IT RESOLVED by the Twenty-Fourth Congress of the
16 Federated States of Micronesia, Third Regular Session, 2026,
17 that Congress hereby approves and accepts the \$26,500 grant
18 from the Multilateral Fund, including all the terms and
19 conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Secretary of the Department of
4 Justice, and the Secretary of the Department of Foreign Affairs.
