A RESOLUTION

To approve and accept a grant in the amount of \$105,000 from the Multilateral Fund (MLF) to support the Federated States of Micronesia second tranche of Stage II of the HCFC Phase – out Management plan, including all the terms and conditions of the assistance.

1 WHEREAS, the Multilateral Fund issued a Grant Award on
2 September 25, 2025, to the Government of the Federated States of
3 Micronesia providing funding in the amount of \$105,000 for the
4 purpose of providing support to the FSM's second tranche of
5 Stage II of the HCFC Phase – out Management plan,

6 WHEREAS, section 210(2) of title 55 of the Code of the
7 Federated States of Micronesia (Annotated), as amended, requires
8 that for foreign financial assistance to be valid it must be
9 approved by Congress by resolution; and

10 WHEREAS, that the Government of the Federated States of
11 Micronesia wishes to express its appreciation and gratitude to
12 the Multilateral Fund for extending this grant; now,
13 therefore,

14 BE IT RESOLVED by the Twenty-Fourth Congress of the
15 Federated States of Micronesia, Third Regular Session, 2026,
16 that Congress hereby approves and accepts the \$105,000 grant
17 from the Multilateral Fund, including all the terms and
18 conditions thereof; and

1 BE IT FURTHER RESOLVED that certified copies of this
2 resolution be transmitted to the President of the Federated
3 States of Micronesia, the Secretary of the Department of
4 Justice, and the Secretary of the Department of Foreign Affairs.


