A RESOLUTION

To approve and accept a grant in the amount of \$180,788 from the United States Department of Health and Human Service, Health Resources and Services Administration, to fund the Maternal and Child Health Services Program, including all the terms and conditions of the assistance.

1 WHEREAS, the Government of the Federated States of Micronesia
2 has received a Notice of Award from the United States Department
3 of Health and Human Services, Health Resources and Services
4 Administration, providing funding in the amount of \$180,788 to
5 support FSM Maternal and Child Health Services Program; and

6 WHEREAS, the purpose of this federal assistance is to improve
7 and strengthen essential health services for mothers and children
8 throughout FSM; and


9 WHEREAS, section 210(2) of title 55 of the Code of the
10 Federated States of Micronesia (Annotated), as amended, provides
11 that for foreign financial assistance to be valid it must be
12 approved by Congress by resolution; now, therefore,

13 BE IT RESOLVED by the Twenty-Fourth Congress of the Federated
14 States of Micronesia, Third Regular Session, 2026, that Congress
15 hereby approves and accepts the \$180,788 grant to fund the
16 Maternal and Child Health Services from the United States
17 Department of Health and Human Services, including all the terms
18 and conditions thereof; and


1 BE IT FURTHER RESOLVED that certified copies of this
