A RESOLUTION

To approve and accept a grant in the amount of \$198,600 from the United States Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment, to fund the Substance Abuse Prevention for the FSM SPF – PFS Project, including all the terms and conditions of the assistance.

1        WHEREAS, the United States Department of Health and Human  
2 Services, Substance Abuse and Mental Health Services  
3 Administration, Center for Substance Abuse Treatment, issued a  
4 Grant Award on September 22, 2025, to the Government of the  
5 Federated States of Micronesia providing funding in the amount of  
6 \$198,600 for the purpose of providing support to the Federated  
7 States of Micronesia SPF – PFS Project; and

8        WHEREAS, section 210(2) of title 55 of the Code of the  
9 Federated States of Micronesia (Annotated), as amended, provides  
10 that for foreign financial assistance to be valid it must be  
11 approved by resolution; now, therefore,

12        BE IT RESOLVED by the Twenty-Fourth Congress of the Federated  
13 States of Micronesia, Third Regular Session, 2026, that Congress  
14 hereby approves and accepts the \$198,600 grant from the United  
15 States Department of Health and Human Services, including all the  
16 terms and conditions thereof; and


