A BILL FOR AN ACT

To further amend Public Law No. 19-60, as amended by Public Laws Nos. 19-71, 19-80, 19-103, 19-148, 19-165, 20-30, 20-128, 21-46, 21-139, 22-120 and 23-100, by amending sections 4 and 6 thereof, to change the use, allottee, and lapse date of certain funds previously appropriated therein, for the purpose of funding essential government functions, programs, projects, and activities in the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 4 of Public Law No. 19-60, as amended by  
2 Public Laws Nos. 19-71 and 19-80, is hereby further amended to  
3 read as follows:

4           "Section 4. Of the sum of \$1,600,000 appropriated by  
5 this act, \$500,000 is apportioned to fund essential  
6 government functions, programs and activities in the  
7 state of Pohnpei.

2       Section 2. Section 6 of Public Law No. 19-60, as amended  
3 by Public Laws Nos. 19-71, 19-80, 19-103, 20-30, 20-128, 21-46,  
4 21-139, 22-120 and 23-100, is hereby further amended to read as  
5 follows:

6           "Section 6. Allotment and management of funds and  
7 lapse date. All funds appropriated by this act shall  
8 be allotted, managed, administered and accounted for  
9 in accordance with applicable laws, including, but  
10 not limited to, the Financial Management Act of 1979.  
11 The allottee shall be responsible for ensuring that  
12 these funds, or so much thereof as may be necessary,  
13 are used solely for the purpose specified in this  
14 act, and that no obligations are incurred in excess  
15 of the sum appropriated. The allottee of the funds  
16 appropriated under section 2 of this act shall be the  
17 Governor of the State of Yap or his designee. The  
18 allottee of the funds appropriated under section 3 of  
19 this act shall be the Governor of the State of Kosrae  
20 or his designee. The allottee of the funds  
21 appropriated under section 4 of this act shall be the  
22 Governor of the State of Pohnpei or his designee;  
23 PROVIDED THAT, the allottee of the fund appropriated  
24 under subsections 4(1)(c), 4(3)(a), 4(3)(c) and  
25 4(4)(a) shall be the Pohnpei Transportation Authority

1 (PTA). The allottee of funds appropriated under  
2 subsections 4(1)(d), 4(1)(e), 4(1)(f), 4(1)(g),  
3 4(1)(h), 4(1)(i), 4(2), 4(3)(e) and 4(4)(b) of this  
4 act shall be the Secretary of Transportation,  
5 Communications and Infrastructure or his designee.  
6 The allottee of the funds appropriated under section  
7 5 of this act shall be the Governor of the State of  
8 Chuuk or his designee. The authority of the allottee  
9 to obligate funds appropriated by this act shall  
10 lapse on September 30, [2026] 2027."

11           Section 3. This act shall become law upon approval by the  
12 President of the Federated States of Micronesia or upon its  
13 becoming law without such approval.
