A BILL FOR AN ACT

To further amend Public Law No. 23-122, as amended by Public Laws Nos. 23-138, 23-146, 24-06 and 24-29, by amending sections 4 and 6 thereof, for the purpose of changing the use and lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1       Section 1. Section 4 of Public Law No. 23-122, as amended by  
2 Public Law No. 24-06, is hereby further amended to read as follows:  
3           "Section 4. Of the \$1,680,000 appropriated under this act,  
4           \$480,000 shall be apportioned to fund public projects and  
5           social programs for the people of Pohnpei.

3 Section 2. Section 6 of Public Law No. 23-122, as amended  
4 by Public Law No. 23-138, is further hereby amended, to read as  
5 follows:

6 "Section 6. Allotment and management of funds and lapse  
7 date. All funds appropriated by this act shall be  
8 allotted, managed, administered and accounted for in  
9 accordance with applicable laws, including, but not  
10 limited to, the Financial Management Act of 1979. The  
11 allottee shall be responsible for ensuring that these  
12 funds, or so much thereof as may be necessary, are used  
13 solely for the purpose specified in this act, and that no  
14 obligations are incurred in excess of the sum  
15 appropriated. The allottee of the funds appropriated  
16 under section 2 of this act shall be the Governor of Yap  
17 or his designee. The allottee of the funds appropriated  
18 under subsection 3(1) of this act shall be the Governor  
19 of Kosrae or his designee. The allottee of the funds  
20 appropriated under subsection 3(2) of this act shall be  
21 the Mayor of Lelu Town Government or his designee. The  
22 allottee of the funds appropriated under section 4 of  
23 this act shall be the President of the Federated States  
24 of Micronesia or his designee. EXCEPT THAT, the allottee  
25 of funds appropriated under section 4(2)(a) of this act

1           shall be the Mayor of Sapuwuafik Municipal Government or  
2           his designee; the allottee of funds appropriated under  
3           section 4(2)(b) of this act shall be the Mayor of Nukuoro  
4           Municipal Government or his designee; the allottee of  
5           funds appropriated under section 4(2)(c) of this act  
6           shall be the Mayor of Kapingamarangi Municipal Government  
7           or his designee; the allottee of funds appropriated under  
8           section 4(2)(k) of this act shall be the Mayor of Sokehs  
9           Municipal Government or his designee; the allottee of  
10          funds appropriated under sections 4(2)(d), 4(2)(e),  
11          4(2)(f), 4(2)(g), 4(2)(h), 4(2)(i), 4(2)(j), 4(2)(l) and  
12          5(6)(a) of this act shall be the Secretary of  
13          Transportation, Communications and Infrastructure or his  
14          designee. The allottee of the funds appropriated under  
15          subsections 5(1) and 5(6) of this act shall be the  
16          Governor of Chuuk State or his designee; the allottee of  
17          the funds appropriated under subsection 5(2) of this act  
18          shall be the Mortlocks Island Development Authority  
19          (MIDA); the allottee of the funds appropriated under  
20          subsection 5(3) of this act shall be the Mayor of Weno  
21          Municipal Government or his designee; the allottee of the  
22          funds appropriated under subsection 5(4) of this act  
23          shall be the Southern Namoneas Development Authority; the  
24          allottee of the funds appropriated under subsection 5(5)  
25          of this act shall be the Faichuk Development Authority.

1           The authority of the allottee to obligate funds  
2           appropriated by this act shall lapse on September 30,  
3           [2026] 2027."

4           Section 3. This act shall become law upon approval by the  
5 President of the Federated States of Micronesia or upon its  
6 becoming law without such approval.
