
A BILL FOR AN ACT

To amend sections 1, 2, 3, 5, 8, 9, 10, and 14 of Public Law No. 24-39, as amended by Public Law No. 24-46, to appropriate \$4,599,800 in supplemental funding from the General Fund of the Federated States of Micronesia for the fiscal year ending September 30, 2026, to provide funding for the Operating Expenses of the Executive Branch; Operating Expenses of the Legislative Branch; Capital and Human Resource Development; and Compact Infrastructure Sector Grant Projects; to expand the permissible use of funds for a certain line item; to add a new subsection for the Operating Expenses of the Office of the Independent Prosecutor; to set the allottee of the funds for the Office of the Independent Prosecutor; and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 1 of Public Law No. 24-39, as amended by
2 Public Law No. 24-46, is hereby further amended to read as
3 follows:

5 follows: To appropriate the sum of [~~\$133,564,006~~]
6 \$138,163,806 from the General Fund of the Federated
7 States of Micronesia for the fiscal year ending
8 September 30, 2026, for the purpose of funding the
9 operations of all branches of the National Government;
10 the operations of [~~the National Public Auditor~~]
11 Independent Offices; the operations of Agencies,
12 Boards, Authorities, and Commissions of the National
13 Government; Special Programs; Grants, Subsidies, and
14 Contributions; Capital and Human Resource Development;
15 Compact Infrastructure Sector Grant Projects and

1 Offices; and Compact IMF Grant Distributions. Of the
2 total amount of funds appropriated herein, \$7,119,994
3 shall be deemed to come from Compact Education Sector
4 Grant; \$410,485 shall be deemed to come from Compact
5 Health Sector Grant; \$765,248 shall be deemed to come
6 from Compact Environment Sector Grant; \$619,030 shall
7 be deemed to come from Compact Private Sector
8 Development Sector Grant; \$2,565,948 shall be deemed
9 to come from Compact Public Sector Capacity Building
10 Sector Grant; \$280,000 shall be deemed to come from
11 Compact Enhanced Reporting and Accountability Sector
12 Grant; [~~\$35,000,000~~] \$38,299,800 shall be deemed to
13 come from Compact Infrastructure Sector Grant to be
14 distributed to the National and State governments
15 pursuant to the grant terms; and \$10,220,000 shall be
16 deemed to come from Compact IMF Grant to be deposited
17 into the National and State IMF sub-accounts pursuant
18 to the grant terms. The sum appropriated herein shall

4 Federated States of Micronesia;

5 (d) Section 5(1) - the allottee of these funds
6 shall be the Public Auditor of the Federated States of
7 Micronesia;

8 (e) Section 5(2) - the allottee of these funds
9 shall be the Independent Prosecutor of the Federated
10 States of Micronesia;

11 (f) Sections 6 through 11 - the allottee of
12 these funds shall be the President of the Federated
13 States of Micronesia; PROVIDED, HOWEVER, that for the
14 following subsections of sections 8 through 11 of this
15 act:

16 (i) Section 8(8) (a) - the allottee of these
17 funds shall be the Governor of the State of Kosrae;

18 (ii) Section 8(8) (b) - the allottee of these
19 funds shall be the Governor of the State of Pohnpei;

20 (iii) Section 8(8) (c) - the allottee of these
21 funds shall be the Governor of the State of Chuuk;

22 (iv) Section 8(8) (d) - the of these funds
23 allottee shall be the Governor of the State of Yap;

24 (v) Section 8(11) - the allottee of these
25 funds shall be the Speaker of the Congress of the

1 Federated States of Micronesia;

2 (vi) Section 8(12)(a) - the allottee of
3 these funds shall be the President of the College of
4 Micronesia-FSM;

5 (vii) Section 8(12)(e) through (h) - the
6 allottee of these funds shall be the Chief Justice of
7 the respective State Supreme Courts;

8 (viii) Section 8(12)(i) - the allottee of
9 these funds shall be the Chief Justice of the Supreme
10 Court of the Federated States of Micronesia;

11 (ix) Section 9 (1) - the allottee of these
12 funds shall be the President of the College of
13 Micronesia-FSM;

14 (x) Section 9(11)(f) - the allottee of
15 these funds shall be the Speaker of the Congress of
16 the Federated States of Micronesia;

17 (xi) Section 9(11)(h) - the allottee of
18 these funds shall be the Governor of the State of Yap;
19 and

20 (xii) Section 10 - the allottee of these
21 funds shall be the Secretary of the Department of
22 Transportation, Communications and Infrastructure.

23 (3) Lapse date. The authority of the allottees to
24 obligate funds appropriated by this act shall lapse as
25 of September 30, 2026; PROVIDED, HOWEVER, that the

1 authority to obligate funds appropriated under
2 sections 9, 10, and 11 of this act shall not lapse."

3 Section 9. This act shall become law upon approval by the
4 President of the Federated States of Micronesia or upon its
5 becoming law without such approval.
