

A BILL FOR AN ACT

To further amend Public Law No. 22-180, as amended by Public Laws Nos. 22-187, 22-188, 23-03, 23-09, 23-11, 23-36, 23-59, 23-118, 23-124, 23-139, 23-145, 24-16 and 24-19, by amending sections 4 and 6 thereof, for the purpose of changing the use, allottee and lapse date of funds previously appropriated therein, to fund public projects and social programs for the people of Yap, Kosrae, Pohnpei and Chuuk States, and for other purposes.

BE LIT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

2 Section 1. Section 4 of Public Law No. 22-180, as

17 Section 2. Section 6 of Public Law No. 22-180, as
 18 amended by Public Laws Nos. 22-188, 23-11, 23-36, 23-118,
 19 23-124, 23-139, 24-16 and 24-19, is hereby further amended
 20 to read as follows:

21 "Section 6. Allotment and management of funds and
 22 lapse date. All funds appropriated by this act shall
 23 be allotted, managed, administered and accounted for
 24 in accordance with applicable laws, including, but not
 25 limited to, the Financial Management Act of 1979. The

1 allottee shall be responsible for ensuring that these
2 funds, or so much thereof as may be necessary, are
3 used solely for the purpose specified in this act, and
4 that no obligations are incurred in excess of the sum
5 appropriated. The allottee of the funds appropriated
6 under section 2 of this act shall be the Governor of
7 Yap State or his designee. The allottee of funds
8 appropriated under sections 3 and 4 of this act shall
9 be the President of the Federated States of Micronesia
10 or his designee; EXCEPT THAT, the allottee of funds
11 appropriated under section 3(1) of this act shall be
12 the Governor of Kosrae State or his designee; the
13 allottee of funds appropriated under section 3(2) of
14 this act shall be the Mayor of Lelu Town Government or
15 his designee; PROVIDED THAT, the allottee of funds
16 appropriated under subsection 3(2)(x) of this act
17 shall be the Mayor of Utwe Municipal Government or his
18 designee; the allottee of funds appropriated under
19 subsection 3(2)(y) of this act shall be the Mayor of
20 Malem or his designee; the allottee of funds
21 appropriated under subsections 4(1)(b), 4(1)(k),
22 4(1)(l), 4(2)(a), 4(2)(b), 4(2)(c), 4(2)(d), 4(2)(e),
23 4(2)(g), 4(2)(h), 4(2)(p), 4(2)(s), 4(2)(t), 4(2)(u),
24 4(2)(v), 4(3)(q) ~~and~~, 4(2)(aa), 4(3)(a) 4(2)(ab) and
25 4(3)(s) of this act shall be the Secretary of the

1 Department of Transportation, Communications and
2 Infrastructure or his designee; the allottee of funds
3 appropriated under subsections 4(1)(a), 4(1)(j),
4 4(2)(f), 4(2)(j), 4(2)(k), 4(2)(l), 4(2)(m), 4(2)(r),
5 4(2)(x), 4(3)(m), 4(3)(n), ~~4(3)(s)~~, 4(2)(n),
6 ~~4(3)(s)~~ 4(3)(u) and 4(3)(t) of this act shall be the
7 Pohnpei Transportation Authority (PTA); the allottee
8 of funds appropriated under subsection 4(2)(i) of this
9 act shall be the Secretary of the Department of
10 Education or her designee; the allottee of funds
11 appropriated under subsection 4(2)(o) of this act
12 shall be the Pohnpei Port Authority (PPA); the
13 allottee of funds appropriated under subsections
14 4(2)(w), 4(2)(q) and 4(2)(z) of this act shall be the
15 Mayor of Sapwuahfik Municipal Government or his
16 designee, the allottee of funds appropriated under
17 subsections 4(2)(ac) and 4(2)(ad) of this act shall be
18 the Sokehs Municipal Government; the allottee of funds
19 appropriated under section 4(3)(e) of this act shall
20 be the Secretary of the Department of Health and
21 Social Affairs; the allottee of the funds appropriated
22 under subsections 5(1) and 5(6) of this act shall be
23 the Governor of Chuuk State or his designee; the
24 allottee of the funds appropriated under subsection
25 5(2) of this act shall be the Mortlocks Island

1 Development Authority (MIDA); the allottee of the
2 funds appropriated under subsection 5(3) of this act
3 shall be the Mayor of Weno Municipal Government or his
4 designee; the allottee of the funds appropriated under
5 subsection 5(4) of this act shall be the Southern
6 Namoneas Development Authority; the allottee of the
7 funds appropriated under subsection 5(5) of this act
8 shall be the Faichuk Development Authority. The
9 authority of the allottee to obligate funds
10 appropriated by this act shall lapse on September 30,
11 [~~2026~~] 2027."

12 Section 3. This act shall become law upon approval by the
13 President of the Federated States of Micronesia or upon its
14 becoming law without such approval.
