
A BILL FOR AN ACT

To further amend Public Law No. 19-121, as amended by Public Laws Nos. 19-130, 19-142, 19-145, 19-158, 20-09, 20-22, 20-51, 20-59, 20-70, 20-123, 20-162, 20-170, 21-35, 21-66, 21-112, 21-127, 21-176, 21-198, 22-07, 22-110, 22-182, 23-86, 23-159 and 24-53, by amending sections 4 and 6 thereof, to change the use and allottee of funds previously appropriated therein, for the purpose of funding public projects and social programs for the people of the state of Pohnpei, and for other purposes.

BE IT ENACTED BY THE CONGRESS OF THE FEDERATED STATES OF MICRONESIA:

1 Section 1. Section 4 of Public Law No. 19-121, as amended by
2 Public Laws Nos. 19-130, 19-142, 19-145, 20-22, 20-51, 20-162 and
3 22-07, is hereby further amended to read as follows:

4 "Section 4. Of the sum of \$5,450,000 appropriated by
5 this act, \$1,200,000 is apportioned to fund public
6 projects and social programs for the people of the state
7 of Pohnpei.

16	Section 2. Section 6 of Public Law No. 19-121, as amended	
17	by Public Laws Nos. 19-130, 19-142, 20-09, 20-70, 20-123, 20-162,	
18	20-170, 21-35, 21-66, 21-127, 21-176, 21-198, 22-07, 22-110 and	
19	23-86, is hereby further amended to read as follows:	
20	"Section 6. Allotment and management of funds and	
21	lapse date. All funds appropriated by this act shall	
22	be allotted, managed, administered and accounted for in	
23	accordance with applicable laws, including, but not	
24	limited to, the Financial Management Act of 1979. The	
25	allottee shall be responsible for ensuring that these	

1 funds, or so much thereof as may be necessary, are used
2 solely for the purpose specified in this act, and that
3 no obligations are incurred in excess of the sum
4 appropriated. The allottee of the funds appropriated
5 under section 2 of this act shall be the Governor of
6 Yap State; PROVIDED THAT, the allottee of funds
7 appropriated under section 2(k) shall be the President
8 of the Federated States of Micronesia. The allottee of
9 funds appropriated under sections 3 and 4 of this act
10 shall be the President of the Federated States of
11 Micronesia or his designee; PROVIDED THAT the allottee
12 of funds appropriated under subsections 3(a) through
13 3(z) shall be the Governor of Kosrae State or his
14 designee; the allottee of funds appropriated under
15 subsections 3(aa) - 3(a11) shall be the Mayor of Lelu
16 Town Government, or his designee EXCEPT THAT the
17 allottee of fund appropriated under subsection 3(au) of
18 this act shall be the Governor of Kosrae or his
19 designee; the allottee of funds appropriated under
20 subsection 4(1)(a) of this act shall be the Governor of
21 Pohnpei State or his designee; the allottee of funds
22 appropriated under subsections 4(1)(l), 4(2)(o),
23 4(3)(a), 4(3)(f) and 4(3)(i) of this act shall be the
24 Pohnpei Transportation Authority (PTA); the allottee of
25 funds appropriated under subsections 4(2)(a), 4(2)(d),

1 4 (2) (e), 4 (2) (f), 4 (2) (g), 4 (2) (h), 4, (2) (i), 4 (2) (j),
2 4 (2) (k), 4 (2) (l), [and] 4 (2) (m) and 4 (3) (p) shall be
3 the Secretary of the Department of Transportation,
4 Communications and Infrastructure or his designee; the
5 allottee of funds appropriated under subsection 4 (2) (b)
6 shall be the Pohnpei Utility Corporation (PUC); the
7 allottee of funds appropriated under subsection 4 (2) (c)
8 shall be the Office of Fisheries, Pohnpei State; the
9 allottee of funds appropriated under subsection 4 (2) (n)
10 shall be the Secretary of the Department of Education
11 or his designee; the allottee of funds appropriated
12 under subsection 4 (3) (b) shall be the Pohnpei State
13 Public Safety; the allottee of funds appropriated under
14 subsections 4 (3) (c) and 4 (3) (e) of this act shall be the
15 Meninkeder of Madolenihmw; allottee of funds
16 appropriated under subsections 4 (3) (d) and 4 (3) (m)
17 shall be the Luhkenmoanolap of Kitti. The allottee of
18 funds appropriated under subsections 5 (1) and 5 (6) of
19 this act shall be the Governor of Chuuk State or his
20 designee. The allottee of funds appropriated under
21 subsection 5 (2) of this act shall be the Mortlock
22 Islands Development Authority. The allottee of funds
23 appropriated under section 5 (3) of this act shall be
24 the Mayor of Weno Municipal Government or his designee.
25 The allottee of funds appropriated under subsection

5(4) of this act shall be the Southern Namoneas
Development Authority. The allottee of funds
appropriated under subsection 5(5) of this act shall be
the Faichuk Development Authority. The authority of
the allottee to obligate funds appropriated by this act
shall lapse on September 30, 2026."

7 Section 3. This act shall become law upon approval by the
8 President of the Federated States of Micronesia or upon its
9 becoming law without such approval.
